SAVE TIME: Copies of these records may be requested and received electronically through **NYC OpenRecords** (<u>https://a860-openrecords.nyc.gov</u>). Alternatively, this completed form may be submitted by postal mail (must also include a stamped, self-addressed envelope).

Please read these instructions carefully before completing this request form:

- For a report of the initial fire emergency response, request the <u>Fire Incident Report</u>. That report will indicate if the responding fire company referred the case to the Bureau of Fire Investigation.
- The Bureau of Fire Investigation typically only investigates complex, fatal, and suspicious fires.
- This form is only used for requesting the "Face Sheet" summary. These summaries often contain enough detail to satisfy the needs of records requestors. The "Face Sheet" indicates the fire location, as well as the cause of the fire (if determined).
- Copies of full Fire Marshal Investigation Reports may only be requested through NYC OpenRecords. Please note that those requests may require significantly more time to fulfill.
- Fire Marshal Investigation Reports can only be released once the investigation has been completed, and only when the release would not otherwise interfere with judicial proceedings.
