

HELLO MY NAME IS NATHANIEL PROVER SR
ON 12-3-19 ME AND ABOUT 15 OTHER DETAINEES MOVED
FROM BROOKLYN DETENTION CENTER TO VERNON C BAIN CENTER
(VCBC) WHERE WE WENT FROM TWO TIRED QUADRANTS
HOLDING AT MOST 28 PEOPLE TO A DORMITORY WHICH HOLDS
50 PEOPLE. AT FIRST THERE WAS 30 TO 35 PEOPLE IN THE
DORM (2CA) THAT I WAS ASSIGNED TO. ON 3-13-20, SOME
DETAINEES WENT TO THE 3RD FLOOR THE REST (INCLUDING ME)
MERGED WITH DETAINEES IN 2CB (NOW IT'S 40 TO 45 PEOPLE)
PROGRAMS AND SERVICES WERE DECENT (AT BEST) WHEN I
WAS HELD IN 2CA, BUT WHEN THE TWO DORMS MERGED
(IN 2CB) THINGS WERE BAD (OVER CROWDING BROUGHT A LOT OF
TENSION AND STRESS) PROGRAMS AND SERVICES BECAME SPORADIC
FOR EXAMPLE IF A LETTER WAS MAILED TO ME FROM MY SISTER
(WHO LIVES IN BROOKLYN 11221 ZIP CODE) IT WOULD ON AVERAGE
TAKE 2 WEEKS TO ARRIVE. THE LAW LIBRARY, LINEN AND UNIFORM
EXCHANGES WERE NOT OFFERED AS SCHEDULED. SO WHEN THE
D.O.C SHUT DOWN BECAUSE OF COVID-19 THINGS GOT WORSE
ON 3-27-20 THE DETAINEES WHO WERE IN 2CA (ME INCLUDED)
ABOUT 19 PEOPLE RETURNED HERE, REASON GIVEN WAS SOCIAL
DISTANCING. THEN ON 3-31-20 (4 DAYS LATER) ALL 19 OF US
WERE MOVED BACK TO 2CB WITHOUT ANY EXPLANATION
(BACK TO 40 TO 45 SOMETIMES AS MUCH AS 48 DETAINEES)
AROUND LATE MAY EARLY JUNE OF 2020 A DETAINEE NAMED
SUAN CRUZ CONTRACTED THE COVID-19 VIRUS (HE LATER DIED)
THE D.O.C TOOK NO EXTRA MEASURES (TESTING ETC... ETC...))
EXCEPT FOR ISSUING MASKS. TO MAKE MATTERS WORSE THE
DORM IN WHICH WE'RE BEING HELD THERE IS NO

AIR CIRCULATION BECAUSE THE WINDOWS ARE SEALED SO CONSEQUENTLY THE AIR WE BREATHE IS NOT PROPERLY RECYCLED. D.O.C OFFICERS ARE ENTERING THE DORM AREA (DURING SHIFTS AND SEARCHES) WITHOUT MASKS FITTED PROPERLY AND HARDLY EVER WITH PLASTIC DISPOSABLE GLOVES. A DETAINEE (CLEVELAND BROADNAX DISABLED FROM A GUNSHOT WOUND) WAS PHYSICALLY REMOVED FROM THE DORM (IN HANDCUFFS AND SHACKLES) ON 7-29-20, A CAPTAIN (NAMED HORTON #679) HAD THIS DONE WHEN MR. BROADNAX ASKED WHY WAS THE OFFICER SEARCHING HIM WAS NOT WEARING PLASTIC DISPOSABLE GLOVES. (THE OFFICER SEARCHING HIM AND HIS PROPERTY WERE PERSONAL GLOVES MADE OF LEATHER) LACK OF SOCIAL DISTANCING CONTINUED TO BE A PROBLEM DUE TO DETAINEE POPULATION (SOMETIMES AS MUCH AS 48 PEOPLE) THEN ON 10-3-20 A DETAINEE NAMED KYLE AUSTON WAS REMOVED FROM THE DORM (DIAGNOSED WITH COVID-19) AND THEN WE ALL TOOK THE TEST FOR THE VIRUS (AFTER THE DORM WAS QUARANTINED) ON 10-4-20. THEN WE STARTED SEEING OFFICERS WEARING MASKS WITH PLASTIC GLOVES (IT WAS LIKE CLOSING THE BARN DOOR AFTER THE HORSE ESCAPED) THIS IS JUST A SMALL SAMPLE OF WHAT THE D.O.C IS AND IS NOT DOING THAT CAUSES MUCH MENTAL STRESS AND FRUSTRATION WHILE AT THE SAME TIME PUTS OUR HEALTH AND SAFETY AT RISK. THOUGH I AM INCARCERATED I AM NOT A SAVAGE! SO I DON'T BELIEVE BEING DISRUPTIVE IS THE SOLUTION. I FEEL THAT HIGHLIGHTING OUR PROBLEMS IN A CIVILIZED MANNER IS THE PROPER WAY TO RESOLVE THEM I HOPE YOU CAN HELP US
