Chairman Joseph Russo began the meeting at 7:00 p.m. with the Pledge of Allegiance.

PUBLIC PARTICIPATION SECTION:

1. R. Press: Mr. Press discussed the Yankee Community Council Youth leadership awards and stated that the NY Yankees don't want to continue the \$500 stipend given to students; he questioned the lack of quorum at the Youth & Education Committee and felt that the selection process should have gone before the full Board. He also questioned the inclusion of an observer in the selection process.

Ruben Diaz, Jr. Borough President 2. L. Rocco: Mr. Rocco complained about not being provided an opportunity to speak at the Municipal Services Committee meeting in February. He would like to see the Board create a document which would serve as a check list for voting on street activity permits. He feels that more oversight is needed when a committee votes on street activity permits.

Mr. Russo advised Mr. Rocco that this will be discussed at the next Executive Board meeting.

- 3. E. Sementilli: Mr. Sementilli echoed Mr. Rocco's comments. He then went on to discuss the numerous qualities-of-life issues within the community. He wants more police assigned to Board 10 and especially patrolling the Pelham Bay area. He requested that Council Member Gjonaj hold hearings.
- 4. T. Rivera: Ms. Rivera works at MGM which has purchased Empire City Casino in Yonkers. MGA/Empire is working to secure a gaming license which would create numerous union worker position. She is collecting signatures wants to secure a gaming license with live games and would create new union jobs. She will be forwarding signatures for a petition to be sent to the Governor.
- R. Rulan: Ms. Rulan is the Bronx Secretary for Relay for Life. Relay for Life is holding several events in Bronx Community Board 10 to promote cancer awareness. First event – February 20, 2020 at Brewski's on East Tremont Avenue followed by a 5K event at Bay Plaza on March 29 and another at Villa Maria Academy on June 27.
- 6. C. Mendogni: Fancy Feet Dance Studio is requesting an overlay on the north west corner of Crosby and Roberts Avenues; highlighted the many efforts undertaken the studio throughout the years. Ms. Mendogni presented the request on February 12, 2020 to the Municipal Services Committee.
- 7. J. O'Neill: Mr. O'Neill introduced himself to the community as representing the Ampere Fishing Club. He noted that due to a scheduled vacation he missed the Economic Development Committee meeting.
- 8. Council Member Mark Gjonaj: thanked the community for their service. He introduced Mr. Tommy Messina who will be his representative at community meetings. His office offers services for the community including senior services, legal services, immigration, housing, tax prep, limited snow removal for seniors, at his office from 8 6 five days a week and after hours by appointment; several mobile offices throughout the community. Call 718-931-1721 for additional details. The Council Member discussed his efforts to secure more police, quality of life issues, lack of timely NYPD response, and harbor boat patrol. He urged the community to report all crimes. Invited the community to the Town Hall on Monday evening 2/24/20 at 6:00 p.m. to talk about the Shelter being proposed for 1400 Blondell Avenue.

YOUTH SERVICES/EDUCATION COMMITTEE: Mr. Bieder

Mr. Bieder disputed the comments made during the public participation section concerning the Yankee Community Council Youth Leadership Awards. He said the Yankees are in favor of the program and the amount is \$750 not \$500. Mr. Bieder went on to discuss the process in which the students were chosen and noted that due to time constraints set by the NY Yankees, it was not possible for the Committee to present to the full Board.

There is no Beacon Program yet for Truman High School; another RFP will be submitted. In the Spring, a Community Board day will be assigned to Board 10 at which the students will be invited onto the Stadium's field and recognized.

The Committee will reach out to the UFT district leaders to attend future meetings.

Chairman Russo said he would like to see the Beacon Program to into Truman High School. Mr. Bieder said that Council Member King's Office has funded the Program, but a provider has yet to be awarded a contract.
