- Department for the Aging DFTA My Ride is a three-year on-demand car service pilot for eligible older adults and individuals with disabilities developed by the New York City Department for the Aging in partnership with the New York City Department of Transportation.

The goals of the pilot are to provide much-needed access to selected eligible participants in transportation desert areas and to study the impact of on-demand car service on participants' social determinants of health. Applicants can apply for the DFTA My Ride pilot <u>online</u> or by mail from Monday, September 13th, 2021 to Friday, October 8th, 2021. Applications are also available in the Board Office.

Mr. Marano suggested that the Committee inform the new members of the history of downzoning in Bronx Community Board 10.

ECONOMIC DEVELOPMENT COMMITTEE: Mr. Accomando

YOUTH SERVICES/EDUCATION COMMITTEE: Mr. Bieder
