

1<sup>st</sup> Vice Chair Guanill began the meeting at 7:00 p.m. with the Pledge of Allegiance.

First order of business was a **Public Hearing on BSA Calendar No. 90-91BZ**, 630-636 City Island Avenue, Bronx, New York 10464, Block 5636, Lot 19, filed pursuant to Sections 72-01 and 72-22 of the Zoning Resolution of the City of New York, as amended to request an amendment of the variance previously granted under BSA Calendar No. 90-91-BZ to permit changes to the previously-approved plans regarding the existing two-story mixed-use commercial and residential building located at the Premises, an extension of the term of the previously granted variance for an additional 20 years, and a waiver of the Board's Rules of Practice and Procedure to allow the filing of the extension of term application after the permitted filing period.

Ms. A. Iannotti from the firm of Sheldon Lobel Esq. discussed the project. The purpose is to request another twenty year extension. This matter was a topic of discussion at the May 14, 2019 Housing & Zoning Committee meeting which was unanimously approved at the Committee level. A discussion and questions were poised concerning parking at the rear of the property. The following resolution was presented:

"Resolved...at the recommendation of Bronx Community Board #10 that the following matter which is scheduled to go before the NYC Board of Standards and Appeals be forwarded to the full Board for approval: BSA Cal. No. 90-91BZ, 630-636 City Island Avenue, Bronx, New York 10464, Block 5636, Lot 19, filed pursuant to Sections 72-01 and 72-22 of the Zoning Resolution of the City of New York, as amended to request an amendment of the variance previously granted under BSA Calendar No, 90-91-BZ to permit changes to the previously-approved plans regarding the existing two-story mixed-use commercial and residential building located at the Premises, an extension of the term of the previously granted variance for an additional 20 years, and a waiver of the Board's Rules of Practice and Procedure to allow the filing of the extension of term application after the permitted filing period."

A motion to accept the Resolution was made by Mr. Bieder, seconded by Mr. Chirico and voted on as follows: All in favor. **The Resolution passed.** 

Next order of business was a <u>Public Hearing on DCA Application #6033-2019-ASWC</u>, an application for an unenclosed sidewalk café at 127 Westchester Square Restaurant LLC, D/B/A Shanghai Red, 127 Westchester Square, Bronx New York 10461-3515, consisting of seventeen tables and thirty four chairs.

Board members discussed times of operation and parking issues. The following resolution was presented:

"Resolved...at the recommendation of the Housing & Zoning Committee of Bronx Community Board #10 that an application for an unenclosed sidewalk café at 127 Westchester Square Restaurant LLC, D/B/A Shanghai Red, 127 Westchester Square, Bronx New York 10461-3515, DCA Application #6033-2019-ASWC, consisting of seventeen tables and thirty four chairs be forwarded to the full Board for approval."

A motion to accept the Resolution was made by Mr. Popovic, seconded by Mr. Accomando and voted on as follows: two (2) in opposition, one (1) abstention, and a majority in favor. **The Resolution passed.** 

A motion to close the Public Hearing session and proceed with the Public Participation session was made by Mr. Accomando, seconded by Mr. Cantillo and approved by all.

## **PUBLIC PARTICIPATION SECTION:**

- 1 Kevin Daloia: Mr. Daloia talked about bike sharing and the positives it brings into communities; he urged the Board to vote in favor of extending the JUMP Bike Program into CB #10.
- 2 Robert Press: Mr. Press discussed his FOIL request sent to CB #10 as well as the subsequent request sent to the Borough President's Office. In addition Mr. Press touched upon a variety of Board topics and mentioned his complaint against Mr. Bieder whom he would like to see terminated from the Board.

- 3 Peter Del-Debbio: Mr. Del-Debbio represented the American Legion, who does not want Miracle City at 2800 Bruckner Boulevard. Mr. Del-Debbio is also against Carnegie Hill Institute.
- 4 Joe Vaini: Mr. Vaini voiced his opposition to Miracle City.
- 5 Judith Martinez: Ms. Martinez is a homeowner near 2800 Bruckner Boulevard and is opposed to 2800 Bruckner Boulevard/Miracle City. The facility does not belong in a neighborhood with 1 and 2 family homes.
- 6 Anibal Vasquez: Mr. Vasquez lives near 2800 Bruckner Boulevard and is against Miracle City.
- 7 Brianna Cohn: Ms. Cohn lives near 2800 Bruckner Boulevard and is against Miracle City. Added that the facility is too close to TOTS (These Our Treasurers School) and (4) local public and (1) parochial schools.
- 8 Debbie Teska: Ms. Teska urged the community to come out and support the July 13, 2019 rally in front of 2800 Bruckner Boulevard against Miracle City.
- 9 Daisy Fraguada.: Ms. Fraguada is on the 2800 Advisory Board; she works with families and children; residents are sensitive to the plight of individuals dealing with substance issues, however the neighborhood is residential, it is too close to TOTS and local schools.
- 10 Egidio Sementilli: Mr. Sementilli has held three rallies against Miracle City at 2800 Bruckner Boulevard; a fourth is scheduled for July 13, 2019. As requested Mr. Sementilli submitted documentation from the local elected officials in opposition of the treatment facility as well as letters from Throgs Neck Homeowners, TOTS, and the American Legion and the change.org petition. He requested that the Board submit its letter of opposition as well.
- 11 Adam Powell, representing Made in Puerto Restaurant: Mr. Powell said the establishment wants to add an additional hour of operation to 3:00 a.m. Thursday-Saturday, and any Sunday before a holiday as well as adding karaoke and a DJ.

Mr. Sementilli interjected and talked about the residents' concerns with noise, etc. Mr. Accomando stated that the Board was not aware of problems because the residents did not contact the Board.

12 – Lou Rocco: Mr. Rocco is opposed to Miracle City; echoed sentiments of Mr. Sementilli and wants an opposition letter sent by the Board.

A motion to close the Public Participation Session was made by Mr. Popovic, seconded by Mr. Chirico and unanimously approved by all.

# **DISTRICT MANAGER'S REPORT**: Mr.Cruz

- Dr. Golden has withdrawn selling 3134 East Tremont Avenue and rejected the proposal from Carnegie Hill Institute; he will remain at the location to continue serving the community for another five ten years
- Miracle City principals visited and spoke with Mr. Cruz; they invited Board members to visit the facility and said they are willing to amend hours to accommodate bus schedule of area schools.
- Bronx Bus Redesign June 19, 2019: Many community residents are against the BX24 traveling along Stadium Avenue, which was also opposed ten years ago.
- Co-op City's Bus Redesign Scoping Session will be June 27, 2019 at 2049 Bartow Avenue.
- District Needs Statement capital and expense items for city agencies: Community is invited to submit requests to the Board Office. A hearing will be in October to discuss the items submitted. The Board does not meet in the summer unless a public hearing is scheduled.
- Projects:
  - I95 Corridor: Assemblyman Benedetto is working with NYS officials to provide a northbound exit from the Hutchinson River Parkway for Co-op City. State DOT will hold a hearing.
  - Sewer/Water main project Burr Avenue and surrounding streets in Pelham Bay

- Unionport Bridge -- temporary bridge to be in place this summer
- Throggs Neck Bridge new decking work throughout the summer
- Traffic light approved for intersection of Crosby and Coddington Avenues
- St. Peters Episcopal Church descendent of the Arnow Family, Jon Arnow, has provided information to the Church's Archdiocese that proves the land on which they want to develop is a burial site for his family
- Mr. Cruz is speaking at the June 25, 2019 Throggs Neck Homeowners Association Meeting, 7:00 p.m. Villa Barone Manor
- Annual Fireworks Event at Orchard Beach: the Board will receive approximately 35 wrist bands. Board members should call the office to reserve.
- \$42,000 has been re-allocated to all community boards as was done last fiscal year; the Board used approximately half of the allocation to secure the services of FedCap.
- Mr. Cruz will continue to monitor all construction applications for compliance with parking.

## **COMMITTEE REPORTS**

# **EXECUTIVE BOARD:** Ms. Guanill

The Committee did not meet in May. Mr. Sullivan emailed the Board members a bullet point document which outlined the By Law changes. Ms. Guanill read the following resolution and made a motion to have it tabled to the next Executive Board. A motion to table the Resolution was made by Mr. Guanill, seconded by Ms. Caruso with the following vote: sixteen (16) in favor of tabling with eleven (11) opposed. **The Resolution did not pass** and will be tabled back to Committee.

"Resolved...at the recommendation of the Chair of Bronx Community Board #10 that the Grievance Policy and By-Law changes be submitted to the full Board for approval.

# **HOUSING/ZONING COMMITTEE:** Mr. Popovic

The Committee met on June 11, 2019. The minutes are self-explanatory. City Planning conducted two presentations: Baychester Avenue rezoning and zoning for coastal resiliency; information is contained in the minutes. Temple Beth El Synagogue is looking for a letter of support for the installation of an electric lift on the side of its property. The Committee voted in favor of the following resolution.

"Resolved...at the recommendation of the Housing & Zoning Committee of Bronx Community Board #10 that the request for a letter of support to be sent to the New York City Department of Buildings concerning the installation of a one-story handicap accessible electric lift on the side of 480 City Island Avenue be forwarded to the full Board for approval."

Board members opened a dialogue. It was felt by many that the request was premature and the establishment should wait until one year has passed. In addition, information became available about an incident with the staff. Security was also discussed. There are no cameras on the exterior and security staff are not doing a good enough job. A community individual claimed to have spoken with residents on Haskins Street about disturbances, but none of these individuals reached out to the Board.

A motion to accept the Resolution for a change in method of operation was made by Mr. Accomando, seconded by Mr. Bieder with the following vote: six (6) in favor, twenty (20) against, one (1) abstention. **The Resolution did not pass.** 

A motion was made to split the resolution into two, one for extension of hours and another for the DJ and karaoke, was made by Mr. Popovic, seconded by Mr. Russo with the following vote: eight (8) in favor, eighteen (18) against. **The Resolution did not pass.** 

# YOUTH & EDUCATION COMMITTEE: Mr. Bieder

The Committee met June 17 and May 27, 2019. Minutes are self-explanatory. The Committee drafted a resolution to send a letter to DOE Superintendent Carranza:

A motion to accept the Resolution was made by Mr. Bieder, seconded by Mr. Smith, with the following vote: (5) five opposed, (1) conflict of interest recusal, and a majority of Board members in favor. **The Resolution passed.** 

A floor motion was presented at the full Board meeting for a street overlay request.

"Resolved...at the recommendation of the Municipal Services Committee of Bronx Community Board #10 that a letter of support to Council Members Mark Gjonaj and Ritchie Torres for a street overlay on East Tremont Avenue between Ericson Place and Little League Place, in honor of Principal Robert Leder who served our community for twenty-seven years as principal of Lehman High School, be forwarded to the full Board for approval."

A motion to support the Resolution was made by Mr. Bieder, seconded by Ms. Baez was voted on favorably by a majority of Board members with one (1) conflict of interest recusal. **The Resolution passed.** 

# PARKS & RECREATION COMMITTEE: Mr. Franklin

The Committee did not meet in June.

## **HEALTH & HUMAN SERVICES:** Mr. Bieder and Mrs. Musano for N. Rosario

The Committee met on May 30, and June 18, 2019. Mrs. Musano went over the June 18 minutes in detail. The Committee met with the Carnegie Hill Institute concerning a program for individuals suffering with substance abuse which may be housed at 3134 East Tremont Avenue. At tonight's meeting, Mrs. Musano noted that Dr. Golden, who owns the property at 3134 East Tremont, withdrew the property from the market.

The following two Resolutions were unanimously approved in Committee:

"Resolved...at the recommendation of the Chairperson of Bronx Community Board #10 to write a letter to our state officials asking them to draft legislation, similar to that of adult zoning resolution entertainment venues, that will prohibit the opening of substance abuse treatment facilities near all schools and public parks and that this be forwarded to the full Board for approval."

Board members discussed the wording of the Resolution. It was determined that the Resolution must be voted on as written; a floor motion can then be made to make any amendment.

A motion to accept the Resolution was made by Mr. Bieder, seconded by Mr. Accomando, with the following vote: six (6) in favor, twenty (20) against. The Resolution did not pass and will be tabled back to Committee for discussion in September.

"Resolved...at the recommendation of the Chairperson of Bronx Community Board #10 to write a letter of objection to the State Department of Health with regard to Miracle City's operation at 2800 Bruckner Boulevard as Mr. Sementilli has submitted the necessary information to the Health and Human Services Committee and that this be forwarded to the full Board.

A motion to accept the Resolution was made by Mr. Bieder, seconded by Mr. Accomando with the following vote: a majority of Board members were in favor, with one (1) opposed. The Resolution passed.
