Mr. Philps is a 17-year city employee where he has served in both City Planning and Bronx Community 4. Mr. Philps complimented the Board Members on their work ethic. He spoke of his efforts to help Community Boards with understanding zoning. Mr. Philps introduced Manny Rivera as the CB #10 City Planning Liaison.
- 2. J. Rosoff, Principal MS 101, Mr. Rosoff introduced himself. Mr. Rosoff has served as 10 years as Principal. Mr. Rosoff invites all Board Members and members of the community to visit the school.
- 3. Leida Velazquez Library Manager of Throggs Neck Library Ms. Velazquez announced that the library is relaunching the Spider-Man library cards. The library contains COVID 19 tests. Baychester Branch will re-open on February 27.
- 4. Debby Kawalick Constituent Ms. Kawalick spoke of the issue of Agua De Coco Bar and Grill. The bar has double parked vehicles and loud noise emanating from the premise.
- 5. Karen Izquierdo Constituent Ms. Izquierdo discussed the issue of the closure of Santa Maria School. Ms. Izquierdo expressed her sadness. Board Member J. Gomez recommended videos of

support from students at Santa Maria School. Board Member A. Torres wants to discuss this issue at a Youth and Education Committee to be scheduled.

### **DISTRICT MANAGER'S REPORT**: Mr. Cruz

Mr. Cruz discussed a proposal of a casino at Trump Golf Links. There may be forthcoming public meetings to discuss. Mr. Cruz reminded the Board Members that the proposal is on parkland and that membership should look to protect parkland. Board Members were reminded that Committee Elections will take place in March. Mr. Cruz informed the public of the impending closure of Santa Maria School. Mr. Cruz reminded Board Members that the application to apply for a Community Board is online and that the staff is able to assist. The Mayor's Executive Order was extended through March which will allow the continued use of virtual meetings.

### **COMMITTEE REPORTS**

### **EXECUTIVE BOARD:** Mr. Russo

The Executive Board met on February 13, 2023. Meetings are self-explanatory. J. Russo mentioned that the Executive Board will review all potential cannabis licenses.

### **HOUSING/ZONING COMMITTEE:** Mr. Popovic

The Committee did not meet in February and will meet on March 14, 2023.

### **ECONOMIC DEVELOPMENT COMMITTEE:** Mr. Accomando

The Committee met on February 7, 2023. Minutes are self-explanatory. All liquor licenses were voted on and are noted above.

### MUNICIPAL SERVICES COMMITTEE: Mr. Bieder

The Committee did not meet in February and will meet on March 8, 2023.

#### PARKS/RECREATION COMMITTEE: Mr. Franklin

The Committee met on February 9, 2023. Mr. Franklin mentioned the RFP for the new Orchard Beach Pavilion. The Community should seek vendors to apply.

### **HEALTH/HUMAN SERVICES:** Ms. Hunt

The Committee did not meet due to technological issues in February and will meet on March 1, 2023. Ms. Hunt spoke of the monthly health initiatives.

### **YOUTH & EDUCATION COMMITTEE:** Ms. Torres

The Committee met on January 23, 2023. The next meeting is February 27, 2023. Ms. Torres spoke "vaping" as a concern for students. TNCAP is to have a seminar on smoking and its effect on adolescent brains. Ms. Torres seeks to coalesce all community partners as smoke shops are selling to students in uniform. Ms. Torres and Mr. Accomando discussed equipping all schools with Narcan. J.

Mondello addressed the Board that there needs to be separation between the sale of cannabis within the store as many stores show the product towards the front of the establishment.

### **ELECTED OFFICIALS:**

Jamaal. Yapp, on behalf of Council Member Riley, is holding a Black History Month Luncheon. There are seats available. J. Yapp thanked the District Manager for sending in requests for the budget.

Tamara Bonet-Cardona, on behalf of Council Member Velazquez, is having Department of Finance officials at their office where constituents can receive help on property taxes. Next Thursday, there will be a virtual workshop with the Department of Consumer and Worker Protection. The Council Member is drafting a letter regarding the closure of the parochial schools within District 13.

Rebecca Nieves, on behalf of Council Member Farias, spoke of free tax prep next Friday, February 24 for those with income less than \$56,000. Monday, February 27 there will be a SNAP and law clinic. On March 2 there will be an older adult services clinic at the District Office. Ms. Nieves acknowledged that Santa Maria School is within Council District 18.

Greer Mayhew, on behalf of Comptroller Lander, spoke of the office's work strengthening heat laws in the City of New York. Black History Month event on February 28 in Harlem. Resident G. Havranek spoke of Hurricane Ida issues and how many homeowners brought claims for damages only to be turned away.

Nipa Royes, on behalf of Congress Member Ocasio Cortez, spoke of the Department of the Youth and Community Development seeking a community member for its advisory board.

Alina Dowe, on behalf of Mayor Adam's office, introduced herself as our Borough Director. Ms. Dowe spoke of the cannabis issues and how to combat the illegal sale. The Mayor signed legislation to help high school students with disabilities as they ascend to college. The Mayor signed legislation to stop the waste of plastic utensils which was promised by Council Member Velazquez. Mayor Adams has launched a podcast. A. Dowe announced the amnesty program for delinquent water bills. Mayor Adams announced having community dinners as a way to help communities engage.
