Chairman Joseph Russo began the meeting at 7:17 p.m. with the Pledge of Allegiance.

PUBLIC PARTICIPATION SECTION:

- 1. Ely Fontanez, Pelham Bay: Mr. Fontanez is requesting assistance with the excessive noise from motorized bicycles and ATVs that congregate on Pelham Parkway during the late evening hours; NYPD disperses the crowd which quickly returns. He wants more enforcement. Also, there is widespread placard abuse of NYPD and MTA workers that he'd like addressed. One location is the vicinity of Burr Avenue to Colonial Avenue as well as hydrants and the parking lot of Burger King.
- 2. NYPL Throgs Neck, Leida Velazquez and Westchester Square, Luz Marin: Libraries are in a crisis and funding cuts may be made to NYPL budgets. They are asking for support; individuals can go online to NYPL.org and submit an online support letter. Throgs Neck Branch will reopen in July; Westchester Square has ongoing programs.
- 3. Vonetta Dudley, Public Health Solutions: organization which works to protect others through tobacco (vaping and cigarettes) control policy. HealthSolutions.Org.

4. Martina Feliz – Tequila Night Lounge: representing the establishment for a liquor license.
