Chairman Russo began the meeting at 7:10 p.m. with the Pledge of Allegiance.

The Public Hearing for District Needs Requests began.

There were no requests presented.

A motion to accept the Resolution for the District Needs Statement for FY 2025 submission to the Mayor was unanimously approved by all. **The Resolution passed.**

A motion to close the Public Hearing was unanimous.

The Full Board commenced after the Public Hearing and the Public Participation began.

PUBLIC PARTICIPATION SECTION:

- 1. State Senator Bailey informed the community regarding 500 Baychester Avenue which bans advertisements signs 1,500 feet of communities with more than one million residents and/or have Mitchell Lama. In Mount Vernon, there will be a community baby shower at 260 South Avenue. The Breast Cancer Walks begins at 8 a.m. at Bayt Plaza. October 28 there will be two Halloween events at the Mall at Bay Plaza and the YMCA.
- 2. Aurea Mangual spoke regarding retirees' health insurance. Retirees will now have to pay out-of-pocket and higher premiums through Medicare Advantage. Ms. Mangual asks that the Community Board supports Council Member Barron's legislation (Intro 1099) to roll back some of these changes.
- 3. Mary Pearson spoke regarding the Metro North Station. The proposed train station will be near DeReimer Avenue. Metro North is only planning for one side of the track. Ms. Pearson refutes there are marshland because vehicles park on this parcel of land. It is accessible from Interstate 95 from Exit 8C.
- 4. Kevin Lambright discussed Bartow Avenue cleanliness.
- 5. Leslie Brown and Rickey Collado spoke of NYPL community programs such as yoga and community centers for teens. City Island Branch is currently closed for emergency repairs. There are covid kits at libraries for free.
- 6. Council Member Amanda Farias discussed work to reduce illegal dumping and Seabury Avenue and Waterbury Avenue. There are non-profits that will be working to help clean. There will be graffiti removal. CM Farias has legislation to have city agencies develop a plan on manufacturing districts in the City of New York.

A motion to close the Public Participation Session was made by Ms. Sajous, seconded by Ms. McMillan and unanimously approved by all.

The terrible repaving job on the I95 by State Department of Transportation contractors was brought to its attention. He thanked Council Member Riley's office for helping with cleaning center medians. He reminded Board Members to be ready at a moment's notice for meetings regarding cannabis applicants as the Board is receiving many at once. 233 Fordham Street is slated to become a "cannabis microbusiness" which does not require Community Board advisement. The Economic Development Committee meeting will be on Monday, November as the First Tuesday is a city holiday.

- J. Yapp CM Riley's office introduced a resolution which calls upon the MTA to change the transfer options to two hours instead of one. October 24 is a hearing to transfer illegal car washes to Department of Sanitation. Intro 384-2022 was enacted on September 3. It creates the Office of Homeowner Advocate within the Housing Preservation and Development.
- T. Winstead State Senator Fernandez's office informed the EBT card "skimming." There is a cash assistance event on Friday, October 20 at the Sotomayor Center in Rosedale Avenue. The small business townhall regarding smoke shops, dispensaries and other agencies on Monday, October 25. There are two Halloween events on October 28 from 3 p.m. to 5 p.m. at Big Deal supermarket.
