First Vice Chair Peter Cantillo began the meeting at 7:00 p.m. with the Pledge of Allegiance.

PUBLIC PARTICIPATION SECTION:

John Sheridan, Water Safety Committee, City Island Civic Association: Mr. Sheridan read a statement which noted the rampant problems arising every year due to boat and jet ski rentals. The Civic Association is advocating for a permanent Harbor Patrol to be housed on City Island and recommended the DOT property on the right side of the bridge, referred to as the Gateway.

Kristle Simms, RN, NP, Jacobi Medical Center: Ms. Simms is representing NYSNA and is advocating for salary parity and safe staffing at Jacobi.

David Malavota, resident of City Island spoke in support of a permanent Harbor Patrol Unit for City Island.

Luana Malavolta, resident of City Island spoke in support of a permanent Harbor Patrol and would like it housed at the Gateway. The current Patrol is currently dispatched from and shared with Queens. She is also advocating for assistance from the Coast Guard.

Mr. Cantillo noted that the request for a Harbor Patrol Unit was included in the Board's Capital Budget Request. Mr. Smith said he is on the Board of the Gateway Project and would not be averse to the sharing of the land. He is against any launching of jet skis in that area.

Cathy Cebek, CICA: Ms. Cebek is requesting a public hearing on the Gateway proposal; she agrees that a Harbor Patrol Unit should be on the site of the proposed Gateway location; the Unit should consist of mobile police, harbor, and ems units. She asked if the Civic Association should submit a proposal for the use of the land. Ms. Cebek is requesting support with a petition for ferry service at Orchard Beach. In closing, she stated that she is against park rangers providing tours of Hart Island.

Bob Bieder, President - 45th Precinct Community Council: precinct council breakfast is at SUNY Maritime College on May 18th, \$20 pp.
