Chairman Joseph Russo began the meeting at 7:00 p.m. with the Pledge of Allegiance.

A public hearing on New York City Department of Planning's City of Yes for Economic Development text amendment was postponed due to unavailability of the presenter. It will be rescheduled before the end of the month.

District 13 City Council Member Kristy Mamorata addressed the community, informing the them that the office is at 3040 East Tremont Avenue, 10461, 718-931-1721. Renata Scalvo will serve as our constituent liaison.

PUBLIC PARTICIPATION SECTION:

- 1. NYPL Leslie Brown, Baychester and Leida Velasquez, Throgs Neck: thanked the community for support; city has paused the upcoming cut; asked for continuing support letters; all programs are still operating.
- 2. Angela Torres, community resident: Ms. Torres is encouraging the community to contact their local NYC Council representative to encourage that the Mayor **not** sign Int 0586-2022. See below for an explanation.

(Board Note: Int 0586-2022: This bill, awaiting signature by the Mayor, would require the NYPD to provide quarterly reports detailing information on level one, two, and three investigative encounters between the police and civilians, including the race/ethnicity, age and gender of the civilian approached by the police, the factors that led to the interaction, and whether the interaction led to a summons or use of force incident. The first such report would be due within 30 days of the quarter ending September 30, 2024.

- 3. Joseph Petranga, community resident: City of Yes for Economic Development is against the housing component of the text amendment
- 4. Deborah Roff, community resident: City of Yes for Economic Development is against the text amendment
- 5. Kevin Daloia, Hutchinson River Greenway: noted that final touches as it relates to greenway and bike access need to be monitored on the Unionport Bridge and the Westchester Avenue Bridge.

(Board Note: Westchester Avenue bridge has been completed; surrounding areas are not yet completed but expect to be by the end of Spring 2024; Unionport Bridge completion is estimated to be December 2024.)

It should be noted that it is not mandatory to have a hearing but the Board wants DCP to know the community may be in opposition. - Casino Proposal there may be a presentation in February and the Board hopes to secure a venue that can accommodate the public.
- The application for an adult-use cannabis dispensary at 3461 East Tremont Avenue, 10465 has been postponed at the applicant's request. It should be noted that this location which formerly housed Paint Puff and Peace was cited for illegal sales. It is no longer in operation.

(NOTE: This bill would allow the NYC Department of Sanitation (DSNY) to impose civil penalties of \$100 per day for the unlicensed operation of a mobile car wash. It would also allow DSNY to tow and remove any vehicle or equipment used to operate licensed or unlicensed mobile car washes upon issuance of a notice of violation for Admin Code \S 16-118(4) or (6) or \S 15-205 (littering from a vehicle into the street).
