First Vice Chair began the meeting at 7:00 p.m. with the Pledge of Allegiance.

1. **PUBLIC HEARING – Housing & Zoning:** A public hearing with respect to BSA #62-13-BZ application to extend the Special Permit for five-years for 2703 East Tremont Avenue (Wendy's), Bronx, New York 10461. Presentation is on Board Website. Application is to renew the drive thru at 2703 East Tremont Avenue.

A brief discussion on the Special Permit was made to the Board and public by Mr. Neil Alexander of Cuddy & Feder LLP, who represented the applicant. There were no previous issues with the facility or the drive thru renewal request. The Committee discussed the application and met with the representatives at the March 12 meeting and recommended approval. There was a very brief comment session followed by the Board's vote.

- George Havranek, SECA: City of Yes discussed the negative effect within the community; suggested that Boards look at the DCP maps to see how the proposal will shape the community; Mr. Havranek suggested that each community board discuss the proposals and also suggested that all NYC council members be contacted.
- 3. Michele Torrioni, PBTA: City of Yes, too much development within the Pelham Bay community, most are as of right projects; discussed illegal smoke shops and wants a pause by the city to not approve future legal dispensaries until the illegal ones are permanently shut down.
- 4. NYPL Libraries, Baychester, City Island, Ms. Brown, Mr. Collado, Ms. Lugo, Ms. Velazquez: there are many free programs for youth and adults. Each requested continuing support and letter writing to restore full funding to libraries.
