Chairman Joseph Russo began the Public Hearing at 7:00 p.m. with the Pledge of Allegiance said by Sgt. Ramirez.

The purpose of this evening's meeting is to vote on two adult-use retail cannabis dispensary applications:

Groovy Vibes LLC 3395 East Tremont Avenue, 10465 Lale Memaj, Applicant Mello Tymes LLC 675 Co-op City Boulevard, 10475 Roger Thomas, Applicant

## **Groovy Vibes LLC**

A presentation was made by the applicant and her representatives. A copy of the presentation was distributed to the Board members and is also available in the Board Office. The applicant and her representatives appeared before the Executive Board in December 2023. The applicant noted that she has a hemp license and has applied for an adult-use retail cannabis dispensary license. The son of the applicant, who is the manager, spoke to the Board to explain the existing CBD/Hemp license and the products currently being sold with that license. He stated the business's goals for the community such as job fairs, educational workshops etc. Security equipment will be throughout the store with professionally trained security officers. There have been no current security issues since opening the CBD/Hemp facility. The operators live and work in the community.

Every Board member was given an opportunity to address the presenters and ask a question or offer comment. The focus of most questioning was the location and its proximity to The Learning Experience institution, which is less than 500 ft. from the existing business. The overall consensus was that the community does not approve this application because the current business is less than 500 feet from an early education child care facility at 2916 Bruckner Boulevard.

## Mello Tymes LLC

A presentation was made by the applicant, Roger Thomas, and his representatives. A copy of the presentation is available in the Board Office. The applicant appeared before the Executive Board in December 2023. The location is in an old bank directly across from Riverbay. Mr. Richard Watson, security officer for the establishment discussed the security measures that would be put in place. Every Board member was given an opportunity to address the presenters and ask a question or offer comment. The consensus was that the community did not want a dispensary.
