

Chairman Peter Sullivan began the meeting at 7:00 p.m. with the Pledge of Allegiance.

The above Community Liaisons were introduced and thanked for coming.

PUBLIC PARTICIPATION SECTION:

1 – Robert Press: introduced himself to the Board and the Community. Mr. Press filed a complaint with the Borough President's Office against a Board member, whom he did not identify. He provided a copy of said complaint to the District Manager as well. Mr. Press strongly feels that he was disrespected and wants to see this Board member removed.

Bishop Rosario gave an update on one student who received the award in 2016. A student from Riverbay, Samantha, received a Yankee scholarship in 2016, is graduating from SUNY Albany this year and will be attending law school.

COMMITTEE REPORTS

EXECUTIVE BOARD: Mr. Sullivan

The Committee met on April 30, 2019. The minutes are self-explanatory. The Executive Board went over the purchase items provided in the minutes and approved all purchases.

The following Resolutions were presented at the full Board meeting of May 16, 2019:

• "Resolved...at the recommendation of the Executive Board of Bronx Community Board #10 to table any and all discussion on attendance until after the June 20, 2019 election and that this be forwarded to the full Board for approval."

Motion to approve Resolution made by Mr. Bieder, seconded by Mr. Cantillo and voted on as follows: approved by a majority of Board members with (2) abstentions. **The Resolution passed.**

• "Resolved...at the recommendation of the Executive Board and the Nominations and Election Committee of Bronx Community Board #10 to implement the hybrid style of election for the 2019 election and that this be forwarded to the full Board for approval."

Motion to approve Resolution made by Mr. Marano, seconded by Bishop Rosario and unanimously approved by all Board members. **The Resolution passed.**

• "Resolved...at the recommendation of the Executive Board of Bronx Community Board #10 to amend Article VI Section II of the Bronx Community By-Laws to allow for the full Board to determine by vote which style of voting it will have each year and that this be forwarded to the full Board for approval."

The above Resolution was amended to read as follows:

• "Resolved...at the recommendation of the Executive Board of Bronx Community Board #10 to amend Article VI Section II of the Bronx Community Board #10 By-Laws to allow for the full Board to determine by vote a hybrid style of voting and that this be forwarded to the full Board for approval."

The Board members discussed the friendly amendment the resolution to a hybrid voting style. A motion to accept the amended resolution was made by Mr. Bieder, seconded by Ms. Woods with the following vote: (9) in favor, (10) against, (2) abstentions. **The Resolution did not pass.**

Since the friendly amendment to the Resolution did not pass, the original resolution was presented and will include the voting styles:

• "Resolved...at the recommendation of the Executive Board of Bronx Community Board #10 to amend Article VI Section II of the Bronx Community By-Laws to allow for the full Board to determine by vote which style of voting (hybrid, paper ballot or roll call) it will have each year and that this be forwarded to the full Board for approval."

A motion to accept the Resolution made by Mr. Marano, seconded by Bishop Rosario and voted on favorably by a majority of Board members with (1) opposed.

• "Resolved...at the recommendation of the Chairperson of Bronx Community Board #10 to write a letter to our state officials asking them to draft legislation, similar to that of adult entertainment venues, that will prohibit the opening of substance abuse treatment facilities near all schools and public parks and that this be forwarded to the full Board for approval."

A motion to table this Resolution back to the Health & Human Services Committee was made by Mr. Bieder, seconded by Mr. Accomando with the following vote: a majority of Board members were in favor, (2) opposed and (1) abstention. **The Resolution will go back to Committee.**

• "Resolved...at the recommendation of the Chairperson of Bronx Community Board #10 to write a letter of objection to the State Department of Health with regard to Miracle City's operation at 2800 Bruckner Boulevard on the condition that Mr. Egidio Sementilli provide any and all necessary statistics and information affirming Bronx Community Board #10 does not need this facility and can provide petitions/letters in opposition from immediate neighbors.

This Resolution is being tabled pending receipt of information from Mr. Sementilli. When received, it will be presented to the Board for a vote.

The following resolution is being presented to the Board on May 16, 2019 to be discussed and voting on June 20, 2019 full Board meeting.

• "Resolved...at the recommendation of the Executive Board, to amend Article IV Section XII of the Bronx Community Board #10 By-Laws that the Board reserve the right at any time during a Full Board or Public Hearing, even without it being placed on the agenda, to vote with a quorum of the Full Board to revoke the courtesy of publicly speaking during a public session to any member of the public for being a public nuisance and that this be forwarded to the full Board for approval."

A "Public Nuisance" shall include but not be limited to continuously breaking Community Board #10's Standing Rules within its By-laws and the Code of Conduct according to New York City Community Board handbook, which can include disturbing either committee or full Board meetings and interfering in internal board business. The member of the public who lost his/her courtesy to speaking during the public session can only be granted the courtesy to speak during the public session by a vote of the Full Board. If the same member of the public continues to violate the Standing Rules and/or the Code of Conduct according to the New York City Community Board handbook, the Board shall ask the member to leave. If he/she refuses to adhere to the request, the proper authority shall be contacted to assist with the removal. A police report shall be filed against this member of the public. At the ensuing Full Board meeting, the Board may vote to ban the member of the public from attending any future Board meetings, whether it be committee, public hearings or at the full Board, for "Continuous Disturbance of the Peace."

ECONOMIC DEVELOPMENT COMMITTEE: Mr. Accomando
