

### **Municipal Services – Floor Resolution**

"Resolved...at the recommendation of the Municipal Services Committee of Bronx Community Board #10, that a letter of support be drafted and sent to NYPD Commissioner Dermot Shea and

the Bronx Borough Command in support of Captain Thomas Fraser and that this be forwarded to the Full Board for its approval."

A motion to accept the Resolution was made by Mr. Bieder, seconded by Mr. Russo. A discussion among the Board members noted the Captain Fraser commitment to the community and his hands on approach in tackling issues. An investigation found that a relationship between the Captain and a subordinate was a consensual one with no favoritism. However, the Captain was transferred. Board members in support of a letter to the Commissioner and Bronx Borough Command hope that it may prove beneficial for his career. There was also sentiment that a letter of recommendation could reflect poorly on Board and its members with an added concern on how it would look to the new Captain.

A vote was taken with the following results: 31 in favor, 5 against, 2 abstentions. **The Resolution passed.**

### **DISTRICT MANAGER'S REPORT**: Mr. Cruz

- COVID-19 infection rate is falling in district
- Masks are available in the Board Office; doubling masking is now recommended by CDC
- DM Cruz is working on securing a vaccination site for the Board 10 service area
- DOT's E Scooter Pilot Program to be implemented in Co-op City, dockless vehicles, bike lanes to be included; program will eventually be expanded to remainder of Board 10.
- Indoor dining open @ 25% capacity; outdoor sidewalk dining has resumed
- Free tax prep programs throughout district; call 311 for free tax preparation; income based for incomes \$68,000 or lower
- Food giveaways throughout the community: CM Gjonaj's office in Pelham Bay on Friday afternoons, Ft. Schuyler Presbyterian Church on Wednesdays
- Committee chairperson, co-chairperson elections will occur in March
- Many testing sites throughout the community, some are pop-ups others permanent.

### **EXECUTIVE BOARD:** Mr. Russo

The Committee met on February 16, 2021. The minutes self-explanatory. The Committee met Kevin Riley new council member District 12, Co-op City.

### **HOUSING/ZONING COMMITTEE:** Mr. Popovic

The Committee met on February 9, 2021. The minutes self-explanatory. The committee discussed the zoning change for Crab Shanty which will result in a public hearing in March at the next full Board meeting on March 18.

# **ECONOMIC DEVELOPMENT COMMITTEE:** Mr. Accomando

The Committee met on February 2, 2021. The minutes are self-explanatory. There were renewals, new and change in method of operation applications for voting. These resolutions are reflected above under Resolutions and all passed unanimously.

### YOUTH SERVICES/EDUCATION COMMITTEE: Mr. Bieder

The Committee did not meet in January. Next meeting is scheduled for Monday, February 22, 2021. New charter school scheduled to start in the Our Lady of Assumption School on Parkview Avenue. The elected officials and Board advocated for a school to be placed in that facility; the new Principal will be in attendance at the February 22, 2021 meeting.

# MUNICIPAL SERVICES COMMITTEE: Ms. Baez for Ms. Velazquez

The Committee met on February 10, 2021. The minutes are self-explanatory. FDNY is providing smoke detectors. Mr., Russo recognized Peter del-Debbio who has been appointed the Board's representative to the Solid Waste Advisory Board (SWAB) which advises the Borough President on recycling issues, organics, and solid waste. SWAB has recently been reactivated in that office and consists of approximately 40 members.

The Committee drafted a floor resolution to be sent in support of Captain Thomas Fraser to the NYPD Commissioner and Bronx Borough Command. This resolution is reflected above under Resolutions.

#### PARKS/RECREATION COMMITTEE: Mr. Franklin

The Committee did not meet this month.

# **HEALTH/HUMAN SERVICES:** Bishop Rosario

The Committee met on January 28, 2021. The minutes are self-explanatory. The VA Hospital has a COVID19 vaccine program for veterans +65 who must be must registered with VA Hospital.
