Housing and Zoning Chair, Louis Popovic began the meeting at 7:05 p.m. with the Pledge of Allegiance.

PUBLIC PARTICIPATION SECTION:

Cinthia Kong, NYC Department of Sanitation: Ms. Kong informed the community about DSNY's leaf collection schedule on November 27 and December 11, 2022. Ms. Kong provided leaf bags to the Board.

NYPL: Leslie Brown – Baychester Branch; Ricky Collado - City Island Branch; Pelham Bay Branch: all NYPL branches are working on returning to pre-pandemic programming schedules including programs for teens, after school activities, community civic engagement. Contact nypl.org for additional information.

Michael Prioletti, Ted Pryor, Bill Stanton, Tom Smith, City Island: all four gentlemen spoke of Richie DiPierro and the request for a street overlay that is to be voted on by the Board. Each one new him personally and spoke of all the good work he did on City Island.

Commanding Officer Catoggio, East Bronx Division, NYPD School Safety: The Division is staying with NYPD and is not being reassigned to DOE. She discussed the objectives, duties and difficulties facing School Safety Agents; these agents are trained in the academy for approximately four months. They do not carry weapons. Outreach is available to any association that requests it. It was noted that there are many gang-related incidents in the Bronx school system. It was also recommended that the 45th Precinct Youth Coordinator Officer Jackson be contacted.
