DISTRICT MANAGER REPORT: Mr. Cruz

Mr. Bieder noted that there was an additional Zoom meeting with DOT with Con Ed concerning a major project scheduled for City Island and the parking issue with a business "squatting" on the land; parking issues with car-share program; and lastly scooters – sidewalk riding issues. Mr. Bieder said the issues were discussed at the Executive Board meeting on 11/14/22 and the Board will go to the media if these issues cannot be resolved soon with DOT.
