Chairman Joseph Russo began the meeting at 7:20 p.m. with the Pledge of Allegiance.

A moment of silence was held for those critically injured in Buffalo and also long time Board member James McQuade.

The Public Hearing began with a reading of the resolution, public speaking and a presentation by the developer.

PUBLIC HEARING on ULURP - C220007MX, CEQR - 22DCP015X

"Resolved... at the recommendation of the Housing and Zoning Committee that the Committee draft a letter of disapproval to the City of New York City Planning Commission on the matter of Uniform Land Use Review Procedure (ULURP) Application C220007ZMX and that this be forwarded to the Full Board for its approval."

PUBLIC PARTICIPATION SECTION:

Mr. Russo read a statement from CM Velazquez who informed the community that due to threats on social media, she will not appear in person but indicated that she will support the community on this project.

There were 28 speakers on the sign-up list. Eighteen (18) voiced opposition to the project. The major areas of concern were school overcrowding, excessive traffic, lack of parking, overpriced food stores, additional strains on the services provided by hospitals, NYPD, FDNY, water/sewer systems and the overall health of residents as the construction will be directly alongside the Bruckner Expressway. Additional comments included that the project will be in a direct flight path of Landing #22 at LaGuardia Airport and is in violation of Federal Law. For the (7) seven speaking in support of the Project the arguments included additional housing for teachers, nurses, police and fire officers, etc. work for the trade organizations and lack of new housing and affordable housing in the area. Mention of a potential education center with sports and other activities could be incorporated into the construction project.

The presentation by the developer included all the reasons above presented by those in support of the project. The presentation is available in the Board Office and interested should request that it be emailed.

Mr. Russo asked for a motion to accept the resolution and stressed that the resolution must be written in the affirmative and a vote in favor of this resolution will result in a negative vote in opposition to the project.

A motion to accept the Resolution was made by Mr. Bieder, seconded by Ms. Caruso and approved as follows: twenty-three (23) in favor, one (1) against, and one (1) recusal **The Resolution passed.**

A motion to close the public hearing was made and approved unanimously.

A request from NYS Senator Luis Sepulveda to speak after the public hearing was granted. Senator Luis Sepulveda, 32nd senatorial district: his district will inherit parts of CB10 if he wins re-election in November.
