HOUSING/ZONING COMMITTEE: Mr. Popovic

The Committee met on April 19, 2022 at Father Albert Hall, St. Benedict's Parish, to hold an information meeting for the community on the Bruckner Up-Zoning Project. Approximately 350 community members were in attendance. Mr. Russo chaired the meeting. Speakers from the various civic associations, NYC Department of City Planning, members of the Housing and Zoning Committee and Board and elected officials spoke. There was a power point presentation by the Throggs Neck LLC.

The Assemblyman discussed with NYPD brass the funding for purchasing of a tow truck for the community and noted that his office is working with the EDC on the reconstruction of the seawall at the end of Vincent Avenue.

Board Members began a discussion on the funding of a community tow truck. Comments included that these types of vehicles are shared among other precincts and cannot be dedicated to one community; discussed the amending of the current summons as well as amending the code used for ticketing the trucks; adding signage; and DSNY should assist in the issuance of summons by DSNY inspectors.

Ms. Prisco noted that the Council Member is Chair of the Subcommittee on Housing and Zoning in the NYC Council.

OLD BUSINESS:

Board member George Havranek requested a follow-up on bail reform with the Senators and inquired about the Board working on the matter. District Manager Cruz said he is in discussion with Senators Bailey and Biaggi to schedule an event. Mr. Havranek inquired about the status of vulnerable properties in the Board area. He also asked about the status of a location for elections for the Spencer Estate community and was informed by District Manager Cruz that the location will be Villa Maria Academy on Country Club Road. Lastly, Mr. Havranek noted that the community was caught off guard by Bruckner Up-zoning Project and asked what the Board can do to assist in getting more timely notifications. It was noted that a revision to the City Charter would be needed, and a commission would need to be created to address the issue. Chairperson Russo said this should be forwarded to the Housing and Zoning Committee.

Board Member Bieder reminded the community about the 45th Precinct Community Council on May 5, 2022.

Board Member Valon Lajçi expressed his dismay at the treatment of the Albanian Community over the delay in the street overlay in Community Board 11.

NEW BUSINESS:

Board Member Valon Lajçi requested that a committee be established to guide new members in procedures and guidelines for new members. District Manager Cruz noted that the Borough President's Office does new member training for all new appointees but this training may have been delayed due to COVID-19.

Chairperson Russo noted that members should have received notification from the office of the Borough President concerning the sexual harassment training.

Board member Maria Caruso noted that the Oyster Reef group is sponsoring an Orchard Beach cleanup at 9 a.m. on May 22, 2022.
