A motion to accept the Resolution for new licenses was made by Mr. Popovic seconded by Ms. Baez and approved as follows: twenty-four in favor, one abstention (Mr. Havranek). **The Resolution passed.**

Board members discussion: Mr. Havranek, who was not present at the Economic Development Committee meeting on March 1, 2022, raised concerns about the potential outdoor noise and stated his objection to the hour of closing outdoors (12 a.m.). It was pointed that this establishment had been thoroughly vetted in Committee, and the outdoor space will be under the NYC Department of Transportation for which the Board has no authority to dictate outdoor hours. It was also noted that the establishment had agreed to shorten its hours to 12 a.m. and there will be no outdoor music. Further discussion among members recommended that the Board request the elected officials to assist with outdoor hours for establishments.

- E-bike program will begin Phase 2 soon; it will be an agenda item at the April 13 Municipal Services meeting with DOT
- School District 11 is holding a virtual meeting 3/23/2022 on the Co-op Safety Education Zone
- Con Ed is holding public hearings next week about a proposed January 2023 rate increase
- Hart Island Transportation Study ZOOM Meeting March 30, 2022
- Orchard Beach E-Waste 5/14/22 R.S.V.P.
- Small Business Services outreach van: DM Cruz will reach out to secure the van for remainder of community
- DOT commercial truck signs request denied.

Mary Jane_Musano requested that a letter be drafted and sent to local elected officials to assist with the setting of outdoor operation hours for establishments with outdoor seating areas. Mr. Bieder said that the NYC Department of Transportation, under which this area falls, has not yet established regulations. He wants to have community board approval included in the regulation process, much like liquor license applications, and that the hours be no later than 10:00 p.m. A motion to accept was made by Mr. Marano, seconded by Mr. Havranek with a unanimous approval by all in attendance.

Mr. Bieder said there is a new mosque at 1501 St. Peters Avenue, Westchester Square Islamic Cultural Center. He'd like to have the local council members and board invited to it's opening ceremony.

Valon Lajçi again raised the delay in the street renaming ceremony for a member of the Albanian American community. It was noted that Mr. Lajçi's concern was addressed earlier in the Board meeting by Council Member Velazquez's representative and will occur on April 9, 2022. In addition, Mr. Bieder pointed out that this issue was not a Community Board #10 matter due to the location of the street renaming and should have been forwarded to Community Board #11. Ms. Chambers added that the concern has been resolved.

Board members Ms. Baez and Ms. McMillan brought up Municipal Services issues concerning bus parking, left turn access out of Locust Point and access to the Ferry from the FFP parking lot which will be handled by DM Cruz.

Motion to adjourn meeting was made by Ms. Sajous with a unanimous approval.
