

Chairman Joseph Russo began the meeting at 7:00 p.m. with the Pledge of Allegiance.

Housing and Zoning Chair, Louis Popovic began the public hearing.

PUBLIC HEARING: NYC Department of City Planning Land Use Application N 210406,

Citywide Hotel Texts Amendment: The proposed zoning change would require City Planning Commission approval for new and enlarged hotels and motels, tourist cabins and boatels in commercial, mixed-use, and paired M1/R districts. The review process would allow the Commission to ensure that new hotels do not create significant conflicts with surrounding development. The existing special permit provisions that apply in M1 districts, which require the Commission to make findings specific to industrially zoned areas, will remain in place.

Discussion: Shawn Brede of Dep. Director Bronx Office, Department of City Planning, presented the text amendment to the Board Members. This amendment is in public review and has been presented to all City Community Boards and Borough Presidents. It is a zoning text amendment for the application of a special hotel permit to create a more consistent approach to hotel development throughout the City. Prior to the pandemic the City of New York experienced record growth which while positive, it created an inconsistent framework. Special permit will not preclude development, just an extra layer of review for new construction.

"Resolved...at the recommendation of the Housing and Zoning Committee of Bronx Community Board #10 that the Department of City Planning Land Use Application N 210406, Citywide Hotel Texts Amendment which is a proposed zoning change requiring City Planning Commission approval for new and enlarged hotels and motels, tourist cabins and boatels in commercial, mixed-use, and paired M1/R districts and that this be forwarded to the full Board for approval."

A motion to accept the Resolution for NYC DCP Application N210406 Citywide Hotel Texts was made by Mr. Accomando, seconded by Mr. Bieder, and voted on as follows: unanimous by all in attendance. **The Resolution passed.** 

The Public Hearing session closed, and Bronx Community Board #10 opened with public participation for the General Board meeting.
