

First Vice Chair Denise Noble began the meeting for Chairman Joseph Russo at 7:06 p.m. with the Pledge of Allegiance.

Department of Cultural Affairs Artwork Presentation: David Mandel, Percent for Art Program: community artwork for the new Bronx Animal Center on Bartow Avenue. Percent for Art works are on display throughout city in publicly accessible locations. The design is conceptual only, it will go to the Public Design Commission for approval.

The Board discussed the proposal.

"Resolved. . .At the recommendation of the Executive Board that a letter be drafted in support of the artwork design selected by the Department of Cultural Affairs for the Bronx Animal Care Center at 2050 Bartow Avenue and that this be forwarded to Full Board its approval."

A motion to accept the Resolution was made by Mr. Bieder, seconded by Mr. Accomando with a vote of 22 in favor, 2 abstentions and 3 against. **The Resolution passed.**

PUBLIC HEARING:

District Manager Matthew Cruz discussed the district's needs for Fiscal Year 2023 which was sent to all Board members. It should be noted that a document had been submitted in advance by Mr. John Sheridan of the City Island Civic Association concerning the creation of a Harbor Patrol Unit for the Bronx. This item had already been included in the District Needs Statement for FY 2023.

"Resolved. . .at the recommendation of the Executive Board of Bronx Community Board #10 that the District Manager submit the annual District Needs Statement for Fiscal Year 2023 to the Mayor of the City of New York and Department of City Planning as part of our annual Charter requirement and that this be forwarded to the Full Board for its approval."

A motion to accept the resolution was made by Mr. Accomando, seconded by Mr. Franklin with the following vote: all in favor. **The Resolution passed.**

The Public Hearing portion was closed and the full Bronx Community Board #10 meeting opened with Resolutions.

4. EXECUTIVE BOARD – Creation of Ad Hoc Nominations and Elections Committee

"Resolved...at the recommendation of the Executive Board of Bronx Community Board #10 that an ad hoc committee be chosen for Executive Board Nominations and Elections, consisting of three members, with elections to take place at the January 20, 2022 full Board meeting and that this be forwarded to the full Board for approval."

A motion to accept the resolution was made by Mr. Bieder, seconded by Mr. Accomando with the following vote: all in favor. **The Resolution passed.**

The Ad Hoc Nominations and Elections Committee will consist of Mrs. Dorothy Krynicki, Mr. Peter Del-Debbio and Ms. Milagros Bufano. Mr. Bieder requested that the committee members receive the guidelines.

5. ECONOMIC DEVELOPMENT – RENEWAL LICENSES

"Resolved...at the recommendation of the Economic Development Committee of Bronx Community Board #10, that the following establishments applying for renewal licenses have agreed to comply with the best management practice standards contained within the Stipulations, by signing them, and to further agree to attend ATAP training, and that their

A motion to accept the resolution was made by Mr. Smith seconded by Mr. Accomando with the following vote: 25 in favor, 1 against and 1 abstention. **The Resolution passed.**

On 10/22/2021 Mr. Bieder said that the NYC School's Chancellor will be stating a position which may negate the need for the press conference. Ms. Torres explained the current situation for attendance.

COMMITTEE REPORTS

EXECUTIVE BOARD: Ms. Noble for Mr. Russo

The Committee met on September 20, 2021 and October 15, 2021. Nomination and Election Ad Hoc Committee volunteers are Mrs Krynicki, Mr. Del-Debbio and Ms. Bufano. These members will work to secure nominations for the Executive Board election to take place in January 2022.

HOUSING/ZONING COMMITTEE:

The Committee did not meet in October. Next meeting is scheduled for November 9, 2021.

ECONOMIC DEVELOPMENT COMMITTEE: Mr. Accomando

The Committee met on October 5, 2021. The minutes are self-explanatory. There were Resolutions for renewal and licenses outlined above and all were approved.

YOUTH SERVICES/EDUCATION COMMITTEE: Mr. Bieder

PARKS/RECREATION COMMITTEE: Mr. Franklin

The Committee met on October 14, 2021. The minutes are self-explanatory. Trump Links will no longer exist as of November 14, 2021; new contract awarded to Bobby Jones Links.

HEALTH/HUMAN SERVICES:

The Committee met on September 23, 2021. The minutes are self-explanatory.

ELECTED OFFICIALS:

NYS Senator Alessandra Biaggi: Senator Biaggi reminded everyone to vote on 5 ballots which will be on the reverse of the voting ballot application: amendment to apportionment and redistricting; right to clean air, water, and clean environment to be added to the NYS constitution; elimination of 10 day advance voter registration requirement; absentee ballot voting – permanent amendment; and increasing

jurisdiction of civil court to hear cases up to \$50,000 (currently at \$25,000). The Senator also discussed the LRAP program (landlord rental assistance program); FEMA assistance availability for renter and home owner properties; US Small Business Administration has a loan program for businesses and homeowners. There will be a job fair 10/23/21 Columbus High School; food empowerment fare -11/20/21 – contact 718-822-2049 for additional information. She noted that a Bill she proposed has been signed into law, mandating that notifications from debt collectors be done in a font size that is legible so those receiving notifications fully understand the "fine" print.

Board member Mr. Bieder wants the criminal justice reform bill readdressed.

Ashley Meza, Office of State Senator Jamaal Bailey: The Senator's Office is planning several events: call 718-547-8854 for locations. The Beacon Program is expected to be running by January 2022.

Mirian Torrado, Office of State Senator Luis Sepulveda: touched upon legislative programs – eviction moratorium: ERAP and workforce diversity program. Constituent services ongoing by appointment only, call 718-991-3161.

Farrah Rubin, Office of NYC Council Member Mark Gjonaj: upcoming events will be shredding events throughout the district, turkey giveaways, spay/neuter clinics. Call 718-931-1161 for locations of all events.

Nikolas Vasquez, Office of U.S. Congress Person Jamaal Bowman: on 10/22 Vice President Kamala Harris is coming to the Borough. Mr. Vasquez noted a legislative effort to work on a far share tax program for billionaires. nikolas.vasquez@mail.house.gov

Hannah Acampora – asked question about middle class taxes and was answered that the tax will apply to individuals earning over one billion dollars in gains.

PUBLIC PARTICIPATION

Cathy Cebek, City Island Civic Association – spoke at recent Parks Committee meeting. CICA is adamantly opposed to a crematorium on Hart Island. The recent study that was released discussed a possible crematorium and the CICA wants the Board to be aware of the issue and supportive of the Association's position.

John Sheridan was also called upon to speak but did not reply.

OLD BUSINESS: Mr. Peter Del-Debbio noted that the District Manager and Board Chair have nominated him to the SWAB Legislative Committee.

NEW BUSINESS:

- Mr. Accomando commented on the bail reform deficiencies and echoed the concerns of Mr. Bieder. He wants the Board to engage with Senator Biaggi on further discussions about the issue.
- Mr. Russo encouraged members to attend the November 6 Harlem Yatch Club event honoring the staff of Bronx Community Board #10.

Motion to close the October 21, 2021 Community Board #10 meeting was made by Mr. Bieder, seconded by Mr. Russo and unanimously approved by all.
