- 11 Leon Tulton, Office of Assemblyman Michael Benedetto: the NYS budget passed with an increase in aid for education, extension of mayoral control over public schools for three years as well as continued funding for higher education. Assemblyman Benedetto has two offices, one on East Tremont Avenue and the other in Co-op City.
- 12 Destiny Cruz, Office of U.S. Congress Member Alexandra Ocasio-Cortez: a Bronx office is being planned and will most likely be in the Pelham Parkway area; call the office at 718-662-5970 for information on visiting the Jackson Heights office for constituent services.

A motion to close the Public Participation Session was made by Mr. Bieder, seconded by Mr. Popovic, and unanimously approved by all.

After the public participation session, the Metropolitan Transit Authority Bridges & Tunnels did a presentation on the upcoming construction coming to the Throggs Neck Bridge. The restoration of the Bronx plaza roadway, improvements to the transition onto the Bridge and improvements to the greenspace are scheduled to start in 2020. In 2019, work on the suspended span, lighting and electrical work will begin. During construction, the center median will be removed and a zipper device will allow for the movement of lanes; deck replacement is expected to take fifteen months; three lanes will remain open during peak travel and lane closures will occur during the late evening and early morning hours. In addition an extension to the Bridge's sound wall will take place. Staging areas are being used for office space, not vehicles; fencing will be moved about 20 feet; law enforcement will be present to keep traffic moving. Questions were posed as to the presence of New York State Police, water runoff, walking/bike lane. NYS Police maintains a barrack on the Bridge and assists the Bridge police as needed. Runoffs will be connected to the DEP storm drain which goes to sewage treatment; DEP opens the system as needed. Notification to local civic associations was done. TBTA will be maintaining the greenspace that belongs to them; part of the property belongs to DOT who will be responsible for their portion. Major congestion problems have been alleviated at Harding Avenue, Locust Point and surrounding streets.

A copy of the presentation will be given to the Board Office for viewing.

A motion to accept the minutes from the March 21, 2019 Bronx Community Board #10 meeting was made by Mr. Bieder, seconded by Ms. Noble, and unanimously approved by all. These minutes will include an amendment to reflect ownership of the property at the left side of the City Island Bridge entering City Island. The parcel of land belongs to the NYC Department of Transportation and another parcel is privately owned.

# **EXECUTIVE COMMITTEE:** Mr. Sullivan

The Committee did not meet in April 2019.

#### Nominations & Elections: Ms. Noble

The Committee met on Wednesday, April 3, 2019. The following resolutions are being presented to the full Board for approval:

"**Resolved**...at the recommendation of the Nominations & Elections Committee that a hybrid style of voting at the full Board elections on June 20, 2019 be forwarded to the full Board for approval."

After a discussion among Board members, a motion was made to table this resolution to the next full Board meeting in order to amend the By-Laws on the voting style for elections. The By-Laws currently state that elections are done by roll call voting. The By-Law change will include paper ballot, hybrid, or roll call and will be presented as a resolution and voted on at the May 16, 2019 full Board meeting.

"**Resolved**...at the recommendation of the Nominations & Elections Committee that the candidate questionnaires be given to the candidates by April 18 and submitted by June 6, 2019."

A motion to accept the Resolution was made by Mr. Accomando, seconded by Ms. Woods and unanimously approved by all members. **The Resolution passed.**

"**Resolved**...at the recommendation of the Nominations & Elections Committee that each candidate for Chairperson be permitted to speak for three minutes at the May 16, 2019 full Board meeting, if he or she so chooses, regarding their candidacy and that candidates will not take questions from members or the public and this be forwarded to the full Board for approval."

Candidate questions for the position of Chairperson must be emailed to bx10@cb.nyc.gov by Board members no later than May 6, 2019. The resolution was amended for ten questions that will be chosen by the Nominations & Elections Committee who will ask the candidates the same questions.

A motion to accept the Resolution was made by Mr. Bieder, seconded by Bishop Rosario and approved by a majority of members, with one abstention. **The Resolution passed.** 

R. Bieder and I. Guanill have accepted their nominations for Chairperson.
All candidates for the position of 1<sup>st</sup> Vice Chair have been seconded.
Mr. Cantillo accepted his nomination for the position of 2<sup>nd</sup> Vice Chair.
Ms. Chambers accepted her nomination for the position of Secretary.
Both candidates for the position of Treasurer have been seconded.
Ms. Musano accepted her nomination; Ms. Velazquez has not yet accepted.

## HOUSING/ZONING COMMITTEE: Mr. Popovic

The Committee met on April 9, 2019. The minutes are self-explanatory. 801 Co-op City Boulevard, 10475 was discussed; this is a project by Simone Development which will go before the Board of Standards & Appeals (BSA) once a hearing date is set. The Board will conduct a public hearing prior to the BSA hearing.

A motion to accept the Resolution was made by Mr. Bieder, seconded by Ms. Chambers and approved by a majority of Board members with one conflict of interest recusal. **The Resolution passed.** 

"Resolved...at the recommendation of the Economic Development Committee of Bronx Community Board #10 that a modification be made to the Board's Set of Stipulations for Liquor Selling Establishments by adding the following narrative at the end of section 7 (Outdoor Area) and that this be forwarded to the full Board for approval: MUSIC FOR OUTDOOR AREA MUST STOP BY 10 PM SUN-THURS AND 11 PM ON FRI & SAT."

A motion to accept the Resolution was made by Mr. Bieder and seconded by Bishop Rosario which was followed by a motion to table the resolution back to the Economic Development Committee by Mr. Sullivan and seconded by P. Cantillo.

The Committee met on March 25, 2019. Minutes are self-explanatory. The Committee will also meet on April 22, 2019.

The Beacon Program is to take place in Truman High School. A letter of support to the NYC Department of Youth and Community Development from Bronx CB #10 for Montefiore Mosholu is being requested as part of the RFP process.

# PARKS/RECREATION COMMITTEE: Ms. Krynicki for Mr. Franklin

The Committee met on April 11, 2019. The minutes are self-explanatory. Road runners discussed their program which operates citywide. Also mentioned was the need for weekend counselors for Pearly Gates Park.

## HEALTH/HUMAN SERVICES: Bishop Rosario

The Committee met on March 26, 2019. The minutes are self-explanatory. At this meeting a resolution was drafted to send a letter to the NYS Senate and Assembly with respect to creating legislation to enforce safe staffing ratios and the elimination of hallway beds. The Committee will meet on April 23, 2019. On that agenda is a discussion on 2800 Bruckner Boulevard.

"**Resolved**...at the recommendation of the Health & Human Services Committee of Bronx Community Board #10 that the Board send a support letter to the New York State Senate and Assembly requesting legislation to enforce safe staffing ratios and the elimination of hallway beds and that this be forwarded to the full Board for approval."

A Resolution to send the support letter was made by Mr. Bieder, seconded by Mr. Popovic and unanimously approved by all.

#### **OLD BUSINESS:**

Mr. Bieder stressed the importance of reading emails sent by the Board Office, especially the ones that are sent high priority with "IMPORTANT-PLEASE READ in the subject line.

Mr. Sullivan noted that if the Board sponsors an event, it should go through the Executive Board. Sponsoring an event does not involve money at the Board level because CB #10 does not have a bank account. An example is the event for May 18, 2019 at Bufano Park. The Board will publicize the event by email and distribute flyers and the Council Member will fund the hiring of an organization called SkateBoogie.net.

Mr. Sullivan stated that the February 2019 meeting did not have a discussion about board member attendance because it was presented to the Board and voted on the following month "As per our By-Laws". He noted that tasks assigned by a Chairperson does not constitute a committee; in addition adhoc committees do not make determinations, only recommendations. Mr. Sullivan reiterated that By-Law amendments are presented one month and then discussed and voted upon the subsequent month.

Ms. Guanill stated that full transparency is needed for all Board members, and feels that the attendance issue was not properly discussed. Mr. Sullivan said it was presented in February, discussed and voted on at the March meeting.
