Chairman Peter Sullivan began the meeting at 7:00 p.m. with the Pledge of Allegiance.

The above Community Liaisons were introduced and thanked for coming.

### **PUBLIC PARTICIPATION SECTION:**

- 1 Dr. E. Rae, President Hutchinson River Restoration Project: Dr. Rae is concerned that the sea walls proposed by the Army Corp of Engineers for the Hudson River will adversely affect estuaries along the Hudson River. Dr. Rae can be contacted at 718-885-9653, hutchinsonrrp@aol.com.
- 2 L. Rocco, WSCA: Mr. Rocco discussed the removal efforts of over forty abandoned/derelict vehicles in the Westchester Square community and discussed community parking issues.

3 – C. Cebek, CICA: City Island is in need of additional police, especially on holidays and the upcoming warmer weather. Ms. Cebek would also like to see an NYPD substation on the Island as well as more traffic control.

Mr. Sullivan noted that the Board has requested additional NYPD staffing and traffic controls for the entire service area. Mr. Bieder added that the 45<sup>th</sup> Precinct has lost approximately five officers due to promotions.

- 4 E. Sementilli, PBCIS Inc: Mr. Sementilli noted his opposition to Business Improvement Districts; he requested a review of the Throgs Neck BID and the Westchester Square BID. He also discussed Blondell Commons and its opposition by both Community Boards 10 and 11.
- 5 A. Aviles, artistic director of Bronx Academy of Arts & Dance (BAAD): Mr. Aviles invited the community to attend upcoming events at 2474 Westchester Avenue, Bronx Academy of Arts and Dance. Arthur@BAAD!Bronx.org
- 6 Clare Hughes, Michelle Braillsford, New York State Nurses Association (NYSNA): Ms. Hughes informed the community of the upcoming nursing strike at area hospitals. Ms. Hughes added that there are very dangerous nurse to patient ratios, and patient care is affected. Ms. Hughes requested the assistance of Community Board #10 in sending a letter to Dr. Steven Sayfer, President of Montefiore.
- 7 Bob Carmody, City Island Chamber of Commerce: Mr. Carmody presented a petition for a traffic light at the corner of City Island Avenue and Pilot Street.
- 8 Bob Bieder, 45<sup>th</sup> Precinct Community Council President: The annual Precinct Council Breakfast is scheduled for May 8, 2019, 8:30 a.m. at the Villa Barone Manor. More information to follow.
- 9 Susan Strazzera, City Island resident: Ms. Strazzera is against the issuance of a liquor license to Caliente at 414 City Island Avenue and is concerned with lack of parking and noise.
- 10 William Cawley, City Island resident: Mr. Cawley is against the issuance of a liquor license to Caliente at 414 City Island Avenue and is concerned with lack of parking and noise.
- 11 Candy Mancuso, City Island resident: Ms. Mancuso is against the issuance of a liquor license to Caliente at 414 City Island Avenue and is concerned with lack of parking and noise.
- 12 Colleen Peccorarro, City Island resident: Ms. Pecoraro is against the issuance of a liquor license to Caliente at 414 City Island Avenue and is concerned with lack of parking and noise.

Chairperson Sullivan addressed the community and said that liquor licenses are governed by the State of New York, not New York City. The Community Board has suggested that establishments close earlier than the allowed 4:00 a.m. NYC 311 should be called for any noise complaints with a request that it be forwarded to the New York City Department of Environmental Protection. Mr. Sullivan said the City Island Civic Association should be contacted concerning the special district designation for the Island. Board member T. Smith, who is also a City Island Civic Association member, said the Civic Association has met with the proprietor and manager. The Civic Association said that the

establishment is amenable to requests made and noted there is no outside area for Caliente. The City Island Civic Association has no objection to the license.

The NYC Department of Education and the offices of the Borough Presidents announce the new program Extended Use Hardship Waiver Program which will pay the DOE permit fees for community organizations who would like to use any DOE facility for community programs.

### **DISTRICT MANAGER'S REPORT**: Mr. Cruz

Mr. Cruz highlighted the following community topics:

- 801 Co-op City Boulevard, a Simone Development project in conjunction with Montefiore for a six story building, applied to the Board of Standard and Appeals for reduced parking spots
- 3660 East Tremont Avenue, McDonald's, property renovation is scheduled to begin in the summer with an opening several months after

- Co-op City Metro North Station sessions are to be scheduled for community involvement; no date yet
- Covenant House, a supportive youth transitional housing, is scheduled to move in to 1550 St. Peters Avenue in April
- Pell Place street signage approved by DOT to be installed shortly
- Vacant lot to the right of the City Island Bridge (exiting CI) will be cleaned; NYC DOT will determine ownership of property; work will commence when owner is contacted for approval
- Bus extension for Section 5 in Co-op City being proposed
- CABO Restaurant's new ownership has not submitted neighborhood petition; the Board will notify the State Liquor Authority
- Economic Development Committee meets on the first Tuesday of every month (except July, August, and December); meeting discusses new and renewal licenses and is open to all. Community can call the Board office with questions on any license.
- CB #10 Committee Chairs should try to have a member on his/her committee from every community
- The April 2019 full Board meeting is on Wednesday, April 17 at 7:00 p.m. due to Holy Thursday
- Patrick Caruso of the Board office has been instrumental in assisting the public with property tax applications for SCHE, SCRIE/DRIE, STAR/ESTAR, VETERANS, CLERGY and DISABLED over the past several months. These programs will reduce property taxes or rents to qualified individuals. Due to his efforts many constituents' taxes have been reduced by half.

#### **COMMITTEE REPORTS**

# **EXECUTIVE BOARD:** Mr. Sullivan

The Committee met on March 20, 2019. Mr. Sullivan went over the minutes which are self-explanatory. Mr. Sullivan noted that topics discussed at Committee meetings and voted on at the full Board level are not readdressed. Elected officials, as community members, may discuss these topics again but the Board will not redo a vote once rendered. In addition, on occasion an item may be brought up at a committee meeting that is not on the agenda for that evening. In the majority of instances, that item will be added to the following month's agenda. This is to ensure as much transparency as possible. If it is a critical time sensitive matter it may be discussed.

The following Resolutions were voted on at the March 21, 2019 CB #10 Board meeting:

• "Resolved...at the recommendation of the Chairperson of Bronx Community Board #10 that a Nominations and Elections Committee be formed for the 2019 Board Elections and that this be forwarded to the full Board for approval."

A motion to accept the Resolution was made by Mr. Bieder, seconded Mr. Accomando and voted on as follows: all in favor. **The Resolution passed.** 

Mr. Sullivan discussed the creation of a Nominations and Elections Committee. Ms. Noble, who volunteered to serve will be the Committee Chair, Mr. Sala volunteered to serve and Mr. Sullivan asked Ms. Krynicki to serve again on the Committee. A motion to accept Ms. Noble as Committee Chair was unanimous.

• "Resolved...at the recommendation of the Chairperson of Bronx Community Board #10 that the proposed merger of the three documents into one By-Law document be forwarded to the full Board for approval."

A motion to accept the Resolution was made by Mr. Bieder, seconded by Mr. Cantillo and voted on as follows: all in favor. **The Resolution passed.** 

Ms. Guanill recognized the document working group, Ms. Chambers, Ms. Davila, Ms. Noble and thanked them for their efforts on the document merger project.

• "Resolved...at the recommendation of the Chairperson of Bronx Community Board #10 that the Veterans Committee be dissolved due to poor attendance and that this be forwarded to the full Board for approval."

A motion to accept the Resolution was made by Mr. Bieder, seconded by Mr. Popovic and voted on as follows: all in favor. **The Resolution passed.** 

• "Resolved...at the recommendation of the Chairperson of Bronx Community Board #10 that a Veterans Group be established and placed under the jurisdiction of the Health and Human Services Committee and to appoint Anthony Salimbene as the Liaison of Community Board #10 to all veterans groups in the Borough of the Bronx and that this be forwarded to the full Board for approval."

A motion to accept the Resolution was made by Mr. Bieder, seconded by Ms. Chambers and voted on as follows: all in favor. **The Resolution passed.** 

### **HOUSING/ZONING COMMITTEE:** Mr. Popovic

The Committee met on March 12, 2019. The minutes are self-explanatory.

Fordham University Alumni is interested in purchasing the property on Country Club Road and plans to donate it to the University for the Rowing Team. The Committee was satisfied with the responses received from the presenters and will draft a letter of support on the concept of the presentation. A motion by Mr. Bieder, seconded by Mr. Accomando to accept the draft support letter was unanimous. Future development projects will be discussed at the next Housing & Zoning Committee meeting.

"Resolved...at the recommendation of the Housing and Zoning Committee of Bronx Community Board #10, that the Board submit a conditional letter of support for 3341 Waterbury Avenue, Bronx, NY 10465 in its request for a special permit at the City Board of Standard and Appeals.

Motion to close the March 21, 2019 Community Board #10 meeting was made by Mr. Bieder, seconded by Mr. Accomando and unanimously approved by all.
