

Mr. Palatnic presented the project to the Board. He stated that the presentation at the Housing & Zoning included erroneous information. It will be one building only, 228 units mixed income, affordable housing. Parking will be available to the public as well. A copy of the presentation is available in the Board Office. Questions were posed by Board members and answered by Mr. Palatnic such as noise studies, parking, - 225 at cellar level; developer is willing to look into converting the commercial space to classroom if an arrangement can be made with a local school. A property owner on Blondell Avenue is in favor and read a statement. The project's developer has spoken to the Westchester Square BID, who is in favor of the project.

The Committee met on, January 15, 2019. The minutes are self-explanatory. One floor motion and two resolutions were presented at the meeting. The Committee was unanimous in forwarded them to the full Board.

a. Floor Motion

Adoption of Bronx Community Board #10 Grievance Policy:

This Resolution was voted on unanimously in favor at the beginning of the January 17, 2019 meeting. **The Resolution passed.**

c. Amendment to the By-Laws – Article VI – Officers, Changing the Month of Election of Officers of the Board, which was presented March 2018:

"Resolved. . .at the recommendation of the Executive Board of Bronx Community Board #10 to move the Board's elections to January starting in 2021 and thereafter, and that this be forwarded to the Full Board for its approval."

A motion to accept the Resolution was made by Mr. Bieder, seconded by Mr. Marano and unanimously approved by all. **The Resolution passed.**

It should be noted that this Resolution has been amended to 2021, instead of 2020. The Executive Board members who are elected as Officers will serve an (18) eighteen month term, from July 2019 – January 2021.
