

Chairman Joseph Russo began the meeting at 7:03 p.m. with the Pledge of Allegiance. Housing and Zoning Chair, Louis Popovic began the public hearing.

Public Hearing: CEQR REFERENCE #: 21DCP045X, ULURP REFERENCE #: 210149ZMX

Crab Shanty Restaurant, 361 City Island Avenue, 10464

A zoning district change is being requested under the above application. Existing zoning is residential and non-conforming; new zoning would conform to current City Island Special District Zoning as a commercial district overlay and if granted by the NYC Department of City Planning, would be permanent. The action would bring the UG 6 eating and drinking establishment on Lot 137 into conformance with the use regulations of the Zoning Resolution, and it would serve to legalize the rear portion of the restaurant that is an addition not covered by the Certificate of Occupancy. The action would establish the parking lot on Lots 122, 124, and 127 as accessory to the eating and drinking establishment on the adjacent Lot 137, and thus a conforming UG 6 use.

### **RESOLUTION:**

"Resolved...at the recommendation of the Housing and Zoning Committee of Bronx Community Board #10 that CEQR REFERENCE #: 21DCP045X, ULURP REFERENCE #: 210149ZMX, Crab Shanty Restaurant, 361 City Island Avenue, Bronx 10464 which seeks a zoning map amendment to rezone all or part of five lots on Block 5633: 120 (p/o), 122, 124 (p/o), 127 (p/o), and 137 (p/o) from R3A to R3A/C1-2 within the Special City Island District to facilitate the continued operation of the restaurant be forwarded to the full Board for approval."

Discussion: There were no objections to this request in the Housing and Zoning Committee. Ms. Dolensek, of the City Island Civic Association, noted that the Association and community is in favor of the project as well.

A motion to accept the Resolution was made by Mr. Bieder, seconded by Mr. Smith with a unanimous vote of all members present. The Resolution passed.

Motion to close the public hearing was unanimously approved by all.
