REPORTS

DISTRICT MANAGER'S REPORT: Mr. Cruz

- District Manager thanked the Board and community for the donations of clothing and pots and pans which were given to families in need and St. Peter's Episcopal Church
- SNAP benefit 15% increase coming
- Municipal Services Committee Chairperson Velazquez and DM Cruz attended a Tech Equity Day of Action at 851 Grand Concourse with the Borough President to bring awareness to students who are still in need of tablets for remote learning. DM Cruz noted that School District 8 which is part of CB#10 has approximately 99% access.
- Health & Human Services Chair Rosario has provided information on a program at the V.A. Hospital which provides food for veterans. Call 718-584-9000, ext 5475 for information.
- Small Business Services has opened a second round of assistance for small business.
- Council Member Kevin Riley, newly elected representing the 12th District, will speak at the February Board meeting.
- New Board members must choose a committee to join. Committee Chairs/Co-Chairs will be up for reelection in March by their respective committee.

EXECUTIVE BOARD: Mr. Russo

The Committee met on January 19, 2021. Minutes are self-explanatory. Mr. Russo noted that on the 1st Thursday of each month the 45th Precinct Council holds it meeting. There is a new Captain, Isaac Ibersol, who has joined the Precinct. Mr. Russo reminded board members to submit their reappointment applications to the office of the BP.

HOUSING/ZONING COMMITTEE: Mr. Popovic

The Committee met on January 12, 2021. Minutes are self-explanatory. Housing & Zoning meeting next month will meet on Crab Shanty.

ECONOMIC DEVELOPMENT COMMITTEE: Mr. Accomando

The Committee met on November 4, 2020. The minutes are self-explanatory. There were applications for renewal, new licenses and a change in method of operation which were favorably voted on in Committee. These resolutions are reflected above under Resolutions. Mr. Accomando added that the establishment owners are showing frustrations over the lack of dining.

YOUTH SERVICES/EDUCATION COMMITTEE: Mr. Bieder

The Committee did not meet in November; next scheduled meeting is Monday, January 25, 2021. Yankee Youth Leadership applications should be available in the next month or so.

MUNICIPAL SERVICES COMMITTEE: Ms. Velazquez

The Committee met on January 13, 2021. Ms. Velazquez went over the minutes, which are self-explanatory. She talked about the I95 Project presentation on the upcoming reconstruction and improvements which will affect the Hutchinson River Parkway and I95. In addition Ms. Velazquez spoke of working with Bishop Rosario of the Health & Human Services Committee on an upcoming joint project to hold a virtual Town Hall on COVID-19.

PARKS/RECREATION COMMITTEE: Mr. Franklin

Committee did not meet in January. Chair Franklin is attending the virtual meeting concerning the Skate Park in Orchard Beach tonight and will report in February.

HEALTH/HUMAN SERVICES: Bishop Rosario

The Committee did not meet in November; next scheduled meeting is Monday, January 28, 2021. Bishop mentioned the joint project with Ms. Velazquez and their respective committees and the V.A. Hospital outreach for food for veterans.

ELECTED OFFICIALS:

Council Member Fernando Cabrera, Chair of Governmental Operations in the NYC Council, discussed the direct impact in the past of being able to secure \$42,000 per community board in NYC. FY21 will result in no funding and will include a \$3,000 budget reduction per board, followed by a FY22 reduction of \$8,000 per board. He is requesting that all Boards draft a letter to the Mayor and OMB encouraging no budget reductions for FY21 and FY22. Mr. Bieder made a motion to send letter to the Mayor and OMB, seconded by Mr. Cantillo who added that the office of the Bronx BP should be included, with a unanimous acceptance.

Angela Conley, Office of NYS Senator Biaggi: discussed the he Paycheck Protection Program which is now accepting applicants for loans, both for first time applicants and for those who received loans during the first round. Applications are being accepted through March 31, 2021. Link to the application <u>https://www.sba.gov/funding-programs/loans/coronavirus-relief-options/paycheck-protection-program</u>. Ms. Conley also talked about the vaccine supply and the office is working on securing additional vaccine locations; one of which is the Lehman High School campus. Farrah Rubin, Office of Council Member Mark Gjonaj: Tonight there was a NYC Bronx Parks meeting on skate park, funded by Council Member Gjonaj. On January 26 there will be another virtual meeting on the flag pole and the office would like to have community input. CM Gjonaj has funded for removal of several abandoned boats. His office is continuing to sponsor COVID-19 testing throughout the community and can assist seniors with applications for receiving the vaccine. Call the office at 718-931-1721 for assistance.

Krystle Cajas, Office of State Senator Sepulveda: Ms. Cajas discussed the recently passed legislation on unemployment benefits, shortages of vaccines as well as the NYS HCR covid rent relief. Marcus Bedinger, Office of U.S. Congressperson Ocasio-Cortez: Call the office for assistance 718-662-6970. Mr. Bedinger informed the community that the office is employing a wounded warrior based out of the NYC office. He also discussed the certification of the presential election as well as legislative efforts, stimulus checks, and extension of eviction moratorium. Chair Russo asked Mr. Bedinger to speak with Health & Human Services Chair Bishop Nancy about veterans services.

Sal Morello, Office of State Senator Bailey: Mr. Morello discussed the legislation on the permanent authorization for absentee ballots to be on line and no-excuse absentee voting legislation (no reason required). The office is holding a January 27, 2021 webinar on human trafficking prevention, and a food giveaway with Assemblyman Benedetto and Council Member Riley on January 27, 2021 at the Section 1 Greenway in Riverbay.
