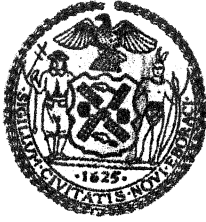

MINUTES OF MEETING HELD MAY 17, 1984 AT THE

KNIGHTS OF COLUMBUS-MARY QUEEN OF PEACE HALL

The meeting was called to order at 8:17 P.M. by Dom Castore, Chairman.

I. Gallery Session

a. Angelo Campanaro - Chester Civic Association

Mr. Campanaro spoke on the sewer work that is going on at Pelham Parkway North and Stillwell Avenue. He stated that they have run into a problem with the pipes. Mr. Campanaro stated that the Pelham Parkway North side has become a dumping ground. He asked for the Board's help on this.

b. Andi Cioffi - Co-President, Parents Association of P.S. 105

Ms. Cioffi spoke on behalf of P.S. 105 and the community. She asked for the Board's support on their request that the Motor Vehicle Bureau find an alternate site, other than the one on White Plains Road and Brady Avenue, for an Adjudication Unit. Ms. Cioffi stated that the community had met with the owner who said that he felt that the community needs more people not more businesses. She stated that he also said that it would not be financially expedient for him to build and divide for individual stores. She stated that he also said that he had purchased the property to protect his interest in a professional building on Morris Park Ave, because he had heard that a group of doctors were interested in the White Plains Road site in order to open up another professional building. Ms. Cioffi said that the owner stated that he was a resident in the Morris Park community and did not want to hurt the Pelham Parkway area. She stated that the owner said that his private survey did not show any children passing the property. Ms. Cioffi stated that according to school attendance records and records of city bus passes issued, there are over 170 children passing the corner of White Plains Road and Brady Avenue twice daily. Ms. Cioffi said that these figures include only those children living south of Brady Avenue, and do not include those children living on Maran Place, Lydig Avenue and on Bronx Park east, who through the school safety plan are directed to go to and from school by passing the site. She also said that the owner stated that he will provide parking for 80 cars.

Ms. Cioffi stated that Senator Calandra, Harriet Windman and Jerry Esposito as well as representatives of almost all our elected officials were present at a recent meeting. She said that Calandra had advised them that not only are there no employment positions other than judgeships available, but that all our elected officials were against this coming into the Pelham Bay and the Pelham Parkway areas. She stated that Borough President Stanley Simon is against the Adjudication Unit also.

Ms. Cioffi stated that she was here tonight without the fanfare, petitions or an entourage or an outcry from the entire Pelham Parkway community, which she stated could be done if necessary, to ask that the Community Planning Board take a position in opposition to the State facility coming into Pelham Parkway.

c. Nat Nevins - Pelham Parkway Block Association

Mr. Nevins stated that there was a meeting of community representatives and organizations with the owner. He stated that after the meeting with the owner the Pelham Parkway Block Association decided to call a meeting on Thursday, May 31st at 8 P.M. at P.S. 105. Mr. Nevins stated that he had called every elected official, and that a letter would be sent to them about the meeting. He asked that the Community Board go on record and send a letter to Commissioner Egan saying that it is against this Adjudication Unit on White Plains Road and Brady Avenue. Mr. Nevins asked all those who represent different organizations to be present at the May 31st meeting. He stated that he had asked the owner, Who made the survey of how many cars go through the area and how many people pass by? Mr. Nevins said that the owner refused to answer him. He said that he is in that area every day, and that you cannot get into the parking lot. Mr. Nevins also said that people pass there all day long, the school is a block away, and that the traffic will be impossible. He asked that Community Board #11 go on record as being against this Adjudication Unit at this site.

Mr. Nevins stated that he had received a letter from Lee Mager in reference to the Bronxdale Pool. He discussed the restrictive clause that was placed on any future sale mandating that it be sold to a non profit group for community use. Mr. Nevins said that he learned that this clause was taken off the property. He said that the Pelham Parkway Block Association feels that the building should be for the benefit of the people in the neighborhood, and he discussed the possibilities for the site. He also said that this clause was removed without the Community Board being notified.

II. Minutes

Corrections

Alfred Tartaglia asked that the Minutes be corrected to show that Steve Lovitch was present at the April meeting.

Tom Brown stated that a correction was necessary on one of the Street Activity Permits. He stated that the street to be closed should have read Pelham Parkway North between Barker Avenue and Bronx Park East and not Boston Road and Bronx Park East.

Motion by Blanche Rifkin - Second by Rhoda Gogatz - That the Minutes be accepted as corrected.

Tony Rizzo stated that he had made the motion to adjourn, but that he was not listed as the maker of the motion.

Tom explained that while Harriet takes notes, unless the voice is clearly recognizable to her, if it is not repeated by the Chair it may not be heard. He suggested that in the future the Chair repeat the name of the maker of the motion and the Second.

Unanimously passed.

III. Chairman's Report

Dom spoke on the Adjudication Unit on White Plains Road. He said that he felt that the Board should send a representative to the meeting on May 31st. He asked Lee Mager, Chairman of the Land Use Committee if he could attend, and Lee said that he would.

IV. District Manager's Report

Tom reported that the District Service Cabinet Minutes had been distributed. He said that it has only been three weeks since the last Cabinet meeting. Tom said that he had been working on the Youth Bureau information needed for the Coordinator position and the Summer Youth Employment Program.

a. Street Activity Permits

Tom stated that there are two Street Activity Permit requests for July 4th, and that both groups had them last year with no problems. He said that both groups were called, and want to have them again this year. Tom said that he did not have the applications yet, as they were just sent to both groups.

1. Hering Avenue between Pelham Parkway South and Lydig Avenue represented by Lucy Palazzolo

Tom said that they have had this block party for the last eight or nine years without any problems.

2. Tenbroeck Avenue between Allerton and Mace Avenues represented by Marie Cammarata

Tom said that they had a block party for the first time last year, and that there were no problems.

Motion by Bob Black - Second by Rhoda Gogatz - That when the applications are received that the Board gives its approval to both groups.

Passed

b. Environmental Protection

Tom said that he had received a call from the Department of Environmental Protection wanting to know what the Board wanted to do about the sprinkler cap program. Tom said that the Board has three options:

1. that the Board have control over the distribution of sprinkler caps
2. that the Board do it in conjunction with the Police Department
3. that the Board have nothing to do with the program and let the Police handle it

Tom said that he told the Department of Environmental Protection that the Board take the responsibility for the sprinkler caps. He said that he always checks with the Police before issuing caps. Tom asked that if the Police receive any requests for sprinkler caps from anyone in District #11 to please refer them to the Community Board. Tom said that he was very careful in giving out the caps last year.

Motion by Bob Black - Second by Rhoda Gogatz - That Community Board #11 take the responsibility for the distribution of the sprinkler caps.

Discussion took place on whether the police were responsible for closing hydrants that they see open without a sprinkler cap.

Det. Tom Lyons spoke on this. He stated that the wrenches are given to radio cars at the start of the summer, but that they are not good wrenches and break easily. Det. Lyons said that they have requested better wrenches for the radio cars.

Dom asked if the police were supposed to shut off hydrants that they see open without a cap.

Det. Lyons said that each radio car is given a few caps, and if they see a hydrant open without a cap they will put a cap on and ask a responsible person to come in and fill out a permit, if it is a location that will not cause any problems.

Tom said that he would be meeting with Environmental Protection and would ask them about supplying sturdier wrenches.

The vote on the motion that the Board be responsible for the caps was passed.

V. Borough President's Report

Barbara Fried reported that the half fare program for seniors and handicapped has been extended one hour by Liberty Lines and the New York Bus Service. She said that the seniors and handicapped are eligible for the \$1.25 fare to and from Manhattan from 9 A.M. rather than 10 A.M. until 3 P.M. Monday through Friday.

Barbara reported that the Board of Estimate had approved a contract between the New York City Department of Parks and Wesler Cohen Assoc. for preparation of plans, specs, etc. in connection with the installation of ballfield lighting and other improvements in Loretto Park, totaling \$36,602.

Office Space

Tom reported that last week the contract for the renovation of the Board's office at the Nurses Residence of Bronx Municipal Hospital Center was signed. He said that there was a brief meeting earlier this week with the hospital, but that the real meeting will be tomorrow at 2:00 between the contractor, the architect and the hospital staff. Tom said that the work should be completed in 6 - 8 weeks.

Bob Black asked if the hospital would be supplying parking spaces. Tom said that the Board had asked for 6 spaces. He said that these are not spaces but permits to park.

VI. Committee Reports

A. Youth Services

Ray Locascio introduced the new Project Director, Ms. Pauline Prilucik.

Ms. Prilucik stated that S.T.O.P. of Community Board #10 and Community Board #11 have gone into a consortium. She stated that we have 265 job slots. She said there are 30 work sites.

Rhoda Gogatz asked Pauline several questions relating to the division of the job slots and how our allocation differed from last year.

Pauline explained that the jobs would be divided equally between both Boards, and that all the Project Sponsors had their allocations cut. She stated that all the applications have been submitted, and that we are waiting for the eligibility list of participants. She stated that there would be a registration and orientation session and asked any Board members who wish, to attend to come and help out. Pauline said that the orientation would be on June 12th and 15th between 2 and 6 P.M. She also stated that orientation would be on June 26th. (The registration date has since been changed)

Youth Coordinator

Ray reported that Linda Stone had gone down for processing last week, and is waiting for the final report that she has been accepted. Ray said that the money has been allocated, and the salary is set. Ray said that Linda should start between June 1st and June 15th. He told Linda that any help she can give Pauline would be appreciated.

Administrator Aid and Crew Chiefs

Ray reported that ads went into the local papers for these positions. He said that Lewis Goldstein and Tom Lucania would be on the screening Committee for these applicants. Ray said that there would be one Administrative Aide and he read the requirements and the salary. Ray said that there would be seven Crew Chiefs and he read the requirements and the salary.

Tom said that copies of this would be sent to all the Associations.

Ray asked anyone who knows someone interested in any of these positions to have them send a resume to the Board office.

Ray reported that there had been a Youth Services Committee meeting last week. He stated that there have been between 20 and 22 people in attendance at each of his meetings.

B. Land Use

1. Extension of Variance 707-56BZ Vol. II - Getty Station at 1500/10 Williamsbridge Road

Lee Mager reported that there have not been any complaints on this station.

Tom stated that Getty discontinued the previous operator, and was now operating it themselves.

Motion by Lee Mager - Second by Rhoda Gogatz, Bob Black and Tony Rizzo -That Community Board #11 waive a Public Hearing and recommend that the Variance extension be granted.

Unanimously passed

C. Highways, Traffic and Transportation

Ernie Odierna reported that there would be a meeting on Monday evening to discuss with the consultants, Andrews and Clark, the preliminary design for streets in the Astor Gardens area. He said that after this meeting, he would schedule a meeting with the community and get its input.

Ernie announced that a traffic signal has been approved for Rhinelander and Hone Avenues. He said that Traffic said that it could take six months, but that they would try to accelerate it.

Ernie read a letter from Traffic on getting in and out of the parking garage on Eastchester Road.

Tom spoke on this. He said that they are talking about eliminating parking twenty feet north of the driveway and ten feet south of the driveway.

Tom said that at Janel Towers they are talking about eliminating twenty feet of parking, east of the driveway on Neill Avenue.

There were no objections to either action.

Frank stated that the Allerton Avenue Association has received complaints from people who use the Liberty Line buses going downtown. Frank said that by the time the bus reach Allerton Avenue it is crowded. He said that there does not seem to be enough buses to accomodate the people who want to get on at Allerton Avenue. Frank said that he spoke with Tom on this this morning on behalf of the Association. He said that many people waiting for empty buses, just line up between the El pillar and curb. Frank asked if a letter could be sent to Liberty Lines indicating that the Board would like to see a dispatcher at that point. He said that the problem starts at 6:30 A.M. and gets worse. Frank said that at Pelham Parkway there are more buses available as well as a full time dispatcher.

Tom said that he has also heard that evening buses have been coming early and this causes a problem at 5:00 P.M. as the buses do not wait at the Pelham Parkway stop until their departure time.

Abe Pereira asked about the Pelham Parkway bus to Wall Street. He said that there is a man that he spoke with today who has a petition of 200 signatures for a bus to Wall Street.

Tom said that he has had two answers to this. He stated that Abe has raised this issue several times. Tom said that he called the Comptroller on this as well as someone from the Bureau of Franchise and Liberty Lines. Tom said that Liberty Lines claims that they do not have the capital to institute the service. He stated that the franchise was granted on a temporary basis but never instituted. He said that there is reluctance to grant the franchise because it would compete with New York City Transit Authority service. Tom suggested that petitions be sent to Liberty Lines with a request that the company reinstitute its franchise application.

A great deal of discussion took place on this.

Tom said that Liberty Lines would have to submit a new application for a franchise.

Motion by Bill Liblick- Second by Rhoda Gogatz - That Community Board #11 send a letter to Liberty Lines requesting that it look into the feasibility of running a bus to Wall Street.

Passed

Ray suggested that the people interested in riding this bus meet with Liberty Lines, and discuss it before the Board sends a letter.

Report on New England Thruway Ramp on Gun Hill Road

Tony Fungiello reported that there would be a meeting on June 10th between representatives of Boards #10, #11 and #12 with Dan Darby, the engineer for the highway. Tony said that after that meeting he would have something to report to the Board.

D. Public Safety

1. 49th Precinct

Joe Reda reported that the inside of the building will be ready by June 15th. He said that the problem is on the outside. Joe said that they are waiting for the soil tests before doing any paving and asphalt work. Joe said that all work should be complete by July 15th and opening by Labor Day.

2. 49th Precinct Council

Joe reported that a meeting was held at Beth Abraham on this. He said that a Steering Committee was formed. Joe said that not everyone was invited because they could not have too many groups. He said that there would be a meeting of the steering committee in June.

E. Community Development and Budget Priorities

Bob Black stated that on behalf of himself and the Officers of Community Board #11 he wanted to thank Tom Brown for his presentation before the Board of Estimate on behalf of Community Board #11.

F. Parks

As Elizabeth Brown was not present Tom gave the report. He stated that he and Elizabeth and several persons representing Board #7 were privileged to meet with Borough President Simon for the ribbon cutting ceremony for the bus stop at the Botanical Garden. Tom said that this was one of the Board's priorities over the years. Tom said that he got off at that stop even before the ribbon cutting.

G. Education and Culture

As Ruth Burko was not present Blanche Rifkin gave the report. Blanche reported that there is a series of articles in the New York Times on Pelham Parkway. She said that it is very favorable, and that there are even pictures.

Tom said that the information of the Capital Budget and its impact on libraries was distributed as well as information on the book sale at the Van Nest branch.

Tom spoke on the Allerton Library roof replacement. He said that this is a long way off, and that barring construction problems they will not have to close the library down at all.

Tom said that construction on the new Eastchester branch library is progressing.

H. Health and Social Services

Bill Liblick asked anyone who would like to serve on the Advisory Board of the group home at 2213 Wallace Avenue to contact the Board or the home directly.

I. Economic Development

As Sal Napolitano was not present Tom gave the report. He stated that he did not know if the Board wanted to take any action on Constantine's request for a tax abatement. Tom gave the background on this. He said that several years ago Constantine's had requested a Zoning change which the Board through U.L.U.R.P. had recommended against. Tom said that it was granted through City Planning and the Board of Estimate. He stated that following this, Constantine's asked to be certified for tax abatement eligibility by the Industrial and Commercial Incentive Board. He said that the Board had recommended against this, but that they were certified eligible. He said that now that the renovation work is finished Constantine's is applying for the abatement itself. Tom said that there is a Public meeting on May 22nd at 10 A.M. at 250 Broadway on the 23rd floor. Tom asked if the Board wanted to change its original position of opposition to this abatement.

Motion by Lee Mager - Second by Rhoda Gogatz - That Community Board #11 recommend that a tax abatement for Constantine's not be granted.

Discussion took place on this and Lee gave the reason's for the Community Board's opposition to the zoning change and abatement.

Passed

J. Housing

Allerton Coops

Frank Muccioli reported that there is still a problem with the Allerton Coops. He stated that Bill Taylor, the President of the Allerton Coops Association has consented to work with the Housing Committee in regard to the Allerton Coops. Frank said that Mr. Taylor has submitted a couple of letters to him. He asked that Mr. Taylor be allowed to explain what the tenants of the Coops are doing, what H.P.D. is doing for them and what progress is being made in the Coops.

Mr. Taylor stated that when last he spoke before the Board there was some disagreement on the status of the application for the loan for the rehabilitation work. Mr. Taylor said that letters were sent from the Housing Committee and Mr. Marvin Goldberg of Community Preservation Corporation. He said that Frank was assured that things were being processed, and that the money was there. Mr. Taylor said that the commitment was signed by Filice Michetti, Deputy Commissioner of Housing and Marvin Goldberg. He said that the work that was to be done would be divided into four parts--boilers; roofs and windows; interior renovations; and exterior renovations. Mr. Taylor said that they have been signed and sent along for action by the general partners of the consortium. Mr. Taylor said that there are twenty or twenty-one partners involved in the ownership of the Coops. He spoke about a conversation he had two years ago in which the name of one of the partners was mentioned. He said that Mr. Traubee had told him "that unfortunately not all my partners are interested in making money". Mr. Taylor said that he had asked to meet with the Attorney General to find out who the owners are. He said that he had been to court six times with the landlord on violations. Mr. Taylor said that he tried to initiate an action on behalf of all the tenants in the Coops and was asked by a representative of H.P.D. why he was trying to fine the landlord when perhaps he should be trying to get a reduction.

Mr. Taylor said that there are over 1,000 violations. He said that the requested rehabilitation monies are not meant to cover the violations, but are designated for capital improvements.

Motion by Frank Muccioli - Second by Rhoda Gogatz - That Community Board #11 write a letter to Ted Weinstein stipulating that the Board would like his office to send inspectors to the Coops to look at the 1,000 violations and have them corrected.

Passed

Discussion took place on the \$1.5 million that Mr. Traubee was supposed to put up.

Frank said that the contractor who was supposed to start the work is no longer interested. He said that another contractor is interested, and that they are working along with him. Frank said that they are now coming up with an ownership obligation. He said that they signed a letter that they are only going to make partial payment of the \$1.5 million to start the work. Frank said that he feels that Mr. Traubee is playing some kind of game with the community and Board. He said that Mr. Traubee had explained to him what his true intent is, and Frank said that it was his feeling that his true intent is to bleed the Coops until some positive action is taken against him. Frank said that it was reported to the Housing Committee that plaster had fallen down in one of the apartments and injured one of the tenant's children.

Brenda Petri stated that she had called C.P.C. on Monday and was told by Mr. Goldberg that "the loan commitment has not been accepted by the borrower, and that the loan commitment for the Coops has expired on its own terms".

K. Nominations

As Steve Zarkin was not present Al Tartaglia spoke. He stated that the Committee had nominated Nicholas Cremonese for the position of Treasurer. He said that he had accepted. Al asked if there were any other nominations, and there were none.

Motion by Al Tartaglia - Second by Leslie McHenry - That nominations for Treasurer be closed.

Passed

Al stated that Brenda Petri had been nominated by the Committee for the position of Secretary, and she had accepted. He asked if there were any other nominations.

Abe Pereira nominated Rhoda Gogatz and Bob Black Seconded the nomination. Rhoda accepted the nomination.

Motion by Al Tartaglia - Second by _____ - That nominations for Secretary be closed.

Passed

Al said that Frank Muccioli had been nominated by the Committee for the position of Second Vice Chairman, and he had accepted. He asked if there were any other nominations, and there were none.

Motion by Rhoda Gogatz - Second by Bob Black - That nominations for Second Vice Chairman be closed.

Passed

Al stated that Dom Castore had been nominated by the Committee for the position of First Vice Chairman, and he had accepted. He asked if there were any other nominations.

Abe Pereira nominated Lewis Goldstein and Kenneth Fleisser Seconded the nomination. Lew accepted the nomination.

Motion by Al Tartaglia - Second by Rhoda Gogatz - That nominations for First Vice Chairman be closed.

Passed

Al said that Lee Mager had been nominated by the Committee for the position of Chairman, and he had accepted. He asked if there were any other nominations, and there were none.

Motion by Abe Pereira - Second by Rhoda Gogatz - That nominations for Chairman be closed.

Passed

VII. Old Business

Tony Rizzo stated that at the last meeting Erskine Place had been discussed. He said that he had some questions.

Tom explained that this is a U.L.U.R.P. application that has not been certified as yet. He explained that it affects Boards #10 and #11. Tom said that on Board #11's side it involves demapping Erskine Place, and he elaborated on why. He stated that no action was required at this time.

Mitchell Lama Buy-outs

Norman Engel spoke on this. He stated that at the last meeting the Board had discussed this. Norman said that he had contacted Senator Bernstein and Assemblyman Friedman, and that he had copies with him of the legislation involved. Norman said that Frank has copies of them also. He asked that the Board publicly back the two bills. Norman said that on June 2nd, they are going to have a big hearing in Manhattan, and that Governor Cuomo has been invited. He said that the Governor was pushing for a Mitchell Lama Buy-out bill. Norman said that this bill must be defeated.

Tom said that at the last meeting he was instructed to get copies of the legislation, and if there was a time problem that the Executive Committee act on it. He said that he only received the legislation early this week. Tom said that it will be at least two weeks before the legislation comes up in the Senate. He also said that it has not been introduced in the Assembly as yet. Tom spoke further on this and said that he did not know anything about Governor Cuomo's bill.

Steven Parness, representative of Eliot Engel spoke on the bill on Buy-outs.

A great deal of discussion took place on this.

The proposed legislation was referred to the Housing Committee for recommendation.

Bronxdale Pool

Tom spoke on this. He gave the background on the property and stated that the Board had recommended that a restrictive clause be placed on the sale so that it

could be sold only for a not-for-profit community use. Tom said that it was passed with this clause in 1980. He said that he had received a highlight auction offering for July 25th in which the Bronxdale was listed without the restrictive clause. Tom said that he had made several calls to City Planning and Real Property, and found out that in 1982 the Commissioner of Real Property had requested the Board of Estimate to have the restrictive clause removed. He said that this request did not have to go through U.L.U.R.P., go to the Board or C.P.C. Tom said that it was a simple resolution of the Board of Estimate. He said that the only way the Board would have known about it was if he read the Board of Estimate calendar, or if he was called about it, which he was not. Tom said that he had sent notices to several community groups on this. He said that next Thursday, the Board of Estimate will have before it the request to approve the sale of the Bronxdale Pool without the restrictive clause.

Motion by Lee Mager - Second by Rhoda Gogatz - That the Board go on record as objecting to the removal of the restrictive clause by the Board of Estimate without the Community Board's knowledge.

Passed

Motion by Lee Mager - Second by Rhoda Gogatz - That Community Board #11 go on record asking that the restrictive clause be placed back on the sale of this property.

Passed

Lee said that he would be attending the meeting on the Adjudication Unit and would report on it at the next meeting.

Motion by Tony Rizzo - Second by Joe Reda - That the meeting be adjourned.

Meeting adjourned at 10:30 P.M.
