# MINUTES OF MEETING HELD THURSDAY, JULY 25, 2005 IN CALVARY HOSPITAL

I. Public Hearing IN THE MATTER OF an application submitted by the Department of City Planning pursuant to sections 197-c and 201 of the New York City Charter fir an amendment of the Zoning Map, Sections Nos. 4a and 4b: - C 050442ZMX the Morris Park Rezoning

Kelly Murphy from the Department of City Planning gave a presentation of the proposal to rezone portions of the Morris Park Community in order to preserve the character of the community.

Ms. Murphy went into details of the zoning package and then opens the floor to questions from Board Members. The areas that are being rezoned would only allow semi-attached and detached houses. This zoning would also reduce the 150 foot commercial encroachment into a residential zone on the side streets to 100 feet. This would also reduce the off-street parking requirement for commercial spaces on Morris Park from one space for every 300 square feet of commercial space to one space for every 1,000 square feet of commercial.

#### **Speakers**

Debra Ann Jaffee – Debra complained that there was not enough community notice on this issue. All though she is in favor of this there was nothing in the newspaper and maybe more people would have been present to let us know their views.

Philip Foglia – Supports this proposal with some reservations. He explained how in his community three family homes, medical facilities and pools have gone up. His reservations about this plan had to do with Jacobi and Einstein properties being left out. He was also concerned about the change in the parking requirement. He also felt that we should go to R3X rather than R4-A or R4-1.

Senator Jeff Klein – Senator Klein thanked the Community Board and City Planning for bringing this issue up.

Over development in our communities is a big problem. He said that we have to preserve what we have in our community. He said that we are not saying that we don't want development in our community; we're not saying that they can't build that in our back year, but we have to be very careful to maintain what we have.

Greg Kisloff – Voiced his support for the rezoning.

That ended the speakers for the public hearing. We had a question and answer period from Board Members and City Planning.

The public hearing was adjourned. Joe McManus thanked Kelly Murphy and Jose Lopez for coming to tonight's meeting.

Special Board Meeting was opened by Dominic Castore, Chairman.

#### Borough President's Report – Jose Candelario

Jose reported that because of the request of Community Board 11 the Borough President funded the purchase of New Curtains for PS 97. The Borough President also allocated \$75,000 for a new sound system for JHS 144. Both schools are located in CB 11. Jose announced that we are going to have a new farmer's market in our area at Our Savior Lutheran School from July 9 to November 19<sup>th</sup> from 8AM to 4PM. Discount coupons are available for seniors.

John reported to the Board about the planned hotel for Pelham Parkway South. John will keep the Board informed on this issue. John did report that this project is an as-of-right project and they need no approvals from the Community Board and the City. John explained the difference between a motel and hotel. He also thanked the Borough President's Office, Councilwoman Provenzano and City Planning for helping us in this fight.
