Full Board Meeting Thursday, November 17, 2016 Einstein College's Lubin Hall – 1200 Van Nest Avenue

Meeting called to order at 7:00 p.m.

- 1. Pledge of Allegiance and Moment of Silence
- 2. Gallery Session
 - a. Denise Pagan, CUNY Hostos Community College, spoke about the Allied Health Carrer Pipeline Program, which offers free job training and which is funded under the federal Affordable Care Act (ACA) and is part of national study. Training is offered for Certified Nursing Assistant (CNA), Clinical Medical Assistant (CMA) and Community Health Worker (CHW) among other titles.
 - b. Marcy Gross, Community Board 11 Member, spoke against the proposed MTA fare hikes and urged members to attend public hearings on the issue and about the Health and Social Services Committee's desire to meet regarding overcrowding at the Montefiore ICU and the hospital generally.
