## March 3, 2016 Economic Development Committee Meeting Minutes

PRESENT: David Leavitt, Chair; Sandra Unger, Co-chair; Dominick Schiano; Silvio Mazzella; and Shradhanand Pirtam.

The meeting was called to order at 7:00 p.m.

- 1. Renewal Liquor License Applications
  - a. Doyle's Pub, 1024 Morris Park Avenue
    The applicant was present. The questionnaire was complete.
    The 49th precinct reported a number of 911 calls to the establishment.

Motion by Dominick Schiano, Seconded by Silvio

Mazzella – That Community Board 11 send an e-mail of 
No Objection to the New York State Liquor Authority

(SLA) regarding this establishment. UNANIMOUSLY

PASSED.

b. Captain's Pizzeria, 1056 Morris Park Avenue
The applicant was present. The questionnaire was complete
except for information regarding the kitchen exhaust system.
The applicant agreed to supply the information to the Board
Office by 3/9/2016. The 49th precinct reported a number of
911 calls to the establishment but the committee did not feel
they were alcohol related. The precinct also reported a
number of 311 calls for blocking the bus stop in front of the

establishment. The applicant said they would take steps to stop the illegal parking.

Motion by Silvio Mazzella, Seconded by Dominick
Schiano – That the Community Board 11 send an e-mail of *No Objection* to the SLA regarding this establishment.
UNANIMOUSLY PASSED.

c. Williamsbridge Diner, 2107 Williamsbridge Road
The applicant was present. The questionnaire was complete except for information regarding the kitchen exhaust system and fire suppression system. The applicant agreed to supply the information to the Board Office by 3/9/2016. The 49th precinct reported a number of 911 calls to the establishment but the committee did not feel they were alcohol related.

Motion by Sandi Unger, Seconded by Dominick Schiano –
That Community Board 11 send an e-mail of *No Objection* to the SLA regarding this establishment.

## UNANIMOUSLY PASSED.

- 2. New Liquor License Application
  - a. Isis Grocery Corp 739 Allerton Avenue
    The applicant was present. The questionnaire was mostly complete but found by the committee to be deficient and to contain numerous inaccuracies and omissions. The 49th Precinct reported that numerous summonses were issued for serving beer without a license and on one occasion the applicant was arrested for warehousing liquor.

    Motion by Silvio Mazella, Seconded by Sandi Unger –That Community Board 11 send an e-mail of *Objection* to the SLA regarding this establishment.

### UNANIMOUSLY PASSED.

b. Corporate Name Change for 900 Park Corp, 900-902
Morris Park Avenue
This item was tabled since the applicant was not present and because the applicant requested a postponement.

### 3. New Business

a. On 2/29/2016, the Board Office received a letter from the attorney for Gasolina (2525 Boston Road) requesting a change in method of operation, which is a request to update the establishment's SLA license to permit live music, DJs and karaoke. The committee members and Board Office staff found public advertising, which suggests Gasolina has engaged in DJs and played live music and karaoke in violation of their current license for at least six months (see the following pages, 4 through 8). The SLA was consulted,

and it was reported to the Office staff that the SLA intends on making a decision on the establishment's change in method request by Monday 3/7/2016.

Motion by Dominick Schiano, Seconded by Sandi Unger – That the Executive Board of Community Board 11 take immediate action to OPPOSE this request and to communicate our opposition to the SLA as soon as possible. **UNANIMOUSLY PASSED.** 

- b. The committee chair will follow up with the Board Office staff about the legal allowable limit that businesses are permitted to encroach on the sidewalks in front of their stores with or without a permit (e.g. fruit/vegetable stores and restaurants).
- c. The committee agreed that all new and renewal liquor license applications should be sent by the Board Office to ALL committee members and not just to the Chair and Cochair when received by the Board Office.
- d. The committee agreed to post the minutes of our meeting to the Board's website; the voice recordings will not be posted to the website.

The next meeting of the Economic Development Committee will be on 4/7/2016 at 7:00 p.m. in the Board Office.

4. Adjournment Meeting adjourned at 8:17 p.m.


