a. Alba Bar Cafe – 2460 Williamsbridge Road: Liquor, Wine, Beer, and Cider.

Applicant was present. 49th Precinct was consulted:

There have been several 911 calls over the past two (2) years for incidents such as fighting, man with a knife, and people refusing to leave location. There was an arrest for serving an underage Auxiliary officer and bartender is no longer with establishment. There have been over 100 summonses issued in the past two (2) years for parking violations.

Applicant claimed he was not aware of some of the 911 calls and was advised by the committee to instruct the employees to advise him of all incidents that occur on the premises and for him to maintain a log of the incidents.

Motion by Dominick Schiano, Seconded by Shradhanand Pirtam – that Community Board 11 send an e-mail of *No Objection* to the New York State Liquor Authority (SLA) regarding this establishment. UNANIMOUSLY PASSED.

b. La Perla Mixteca Restaurant Corp. – 2819 White Plains Road: Liquor, Wine, Beer, and Cider.

Applicant was present. 49th Precinct was consulted. Only issue is parking. Location was tested on two occasions and both times an underage Auxiliary officer was turned away.
