1. Renewal Liquor License Application(s):

- a. Royal Coach Diner – 3620 Boston Road: Liquor, Wine, Beer and Cider.

Applicant was present. 49<sup>th</sup> Precinct was consulted and had no issues.

Motion by Dominick Schiano, Seconded by Tony Signorile – that Community Board 11 send an e-mail of **No Objection** to the New York State Liquor Authority (SLA) regarding this establishment. **UNANIMOUSLY PASSED.**

- b. Captain’s Pizzeria – 1056 Morris Park Avenue: Liquor, Wine, Beer, and Cider.

Applicant was present. 49<sup>th</sup> Precinct was consulted and had no issues.

Motion by Dominick Schiano, Seconded by Tony Signorile – that Community Board 11 send an e-mail of **No Objection** to the New York State Liquor Authority (SLA) regarding this establishment. **UNANIMOUSLY PASSED.**

- c. Williamsbridge Diner Inc. – 2107 Williamsbridge Road: Liquor, Wine, Beer, and Cider.

Applicant was present. 49<sup>th</sup> Precinct was consulted and had no issues.

Motion by Dominick Schiano, Seconded by Shradhanand Pirtam – that Community Board 11 send an e-mail of **No Objection** to the New York State Liquor Authority (SLA) regarding this establishment. **UNANIMOUSLY PASSED.**

2. New Liquor License Application(s):

- a. 1024 Morris Park Restaurant Inc. – 1024 Morris Park Avenue: Liquor, Wine, Beer and Cider.

Applicant was present. 49<sup>th</sup> Precinct was consulted and had no issues.

Motion by Dominick Schiano, Seconded by Veronica Castro – that Community Board 11 send an e-mail of **No Objection** to the New York State Liquor Authority (SLA) regarding this establishment provided that applicant signs a stipulation agreement that liquor would be served only from 10 a.m. to 3 a.m. **UNANIMOUSLY PASSED.**

3. Request for Extension of Business Hours:

- a. Ruby's Restaurant – 600 Van Nest Avenue.

Requesting an extension of hours to 4 a.m. 49 consulted and had no objections.

Motion by Shradhanand Pirtam, seconded by Dominick Schiano of **No Objection** to the extension of hours provided that applicant sign a stipulation agreement that liquor would be served Monday thru Thursday until Midnight, Friday thru Saturday until 4 a.m. Tony Signorile abstained. **MOTION PASSED.**

- b. La Parranda Bar Restaurant Inc. – 2712 White Plains Road

Currently serving liquor Sunday thru Wednesday until Midnight and Thursday thru Saturday until 1 a.m. Requesting an extension of hours to 4 a.m.

Applicant was present. 49<sup>th</sup> Precinct was consulted. The area where establishment is located is a problematic area in general and hours they are requesting to be able to extend to are during problematic times.

Motion by Dominick Schiano, Seconded by Shradhanand Pirtam of **No Objection** to the extension of hours provided that applicant sign a stipulation agreement that liquor would be served Sunday thru Wednesday until 1 a.m., Thursday thru Saturday until 1:30 a.m. Veronica Castro abstained for cause. **MOTION PASSED**
