BSA Application for 974 Sackett Avenue
 The application for 974 Sackett is to legalize its historical use of vehicle

Department of City Planning's draft recommendations for the proposed Metro

North stations in Morris Park and Van Nest The issue of parking was brought up. There were no specifics given but there are two planning sessions scheduled, which are open to the public:

The Committee made clear that this was not a re-vote on the matter. Council Member Gjonaj spoke about his concerns that if proposals such as these are rejected, then the property owners might put up an as-of-right homeless shelter because this is legally allowed. There was much discussion on the issue.

Many present were still against the property owner's proposal. Ken Gelnick believed the issue merits further discussion and stated that the Community Board should possibly have a public hearing on whether the Zoning Resolution should be amended to require special permits for shelters at all times. Currently, there is no such requirement.

It should be noted that two members of the public were expelled from this part of the meeting for disruptive behavior.
