- · This led to a discussion about street or pop-up car washes and use of hydrants. Street car washes are now legal as long as the operators obtain a permit from the Department of Consumer and Worker Protection, and can apply for a Hydrant Use Permit from DEP. The committee may follow up on this matter at a later meeting in the future if there is interest.
- B. Committee members were asked to submit their concerns/problems/issues prevalent in their neighborhoods that CB 7 may be able to address through advocacy and dovetail into our budget request.
 - 1.) The streets are not cleaned and t phantom abandoned cars and cars without license plates are parked and not being moved for alternate side street parking and cleaning. Enforcement by NYPD, DSNY
 - 2.) Some of those phantom cars and cars without license plates are parked near hydrants. Enforcement by NYPD, DSNY
 - 3.) Many sidewalks are also very dirty with garbage, plastic bags, bottles, etc. Homeowners/apt owners are not cleaning daily or as soon as the property is cleaned, others come by and dump their garbage. Enforcement by DSNY
- C. Capital & Expense Budget Requests Agency Responses

The committee discussed the agency responses and considered a few for further action with the appropriate agencies and elected officials.

· Increase in sanitation enforcement personnel to address violations of dirty sidewalks by merchants, street vendors, and homeowners.

o Include BIDs to help with educating and outreach to commercial owners.
