- I) PUBLIC SESSION ANNOUNCEMENTS
 - A) Alex Kratz, Norwood News: Spoke about publishing in the local paper
 - B) 52nd Pct. Deputy Inspector James Alles:
 - 1) Crime statistics and arrests throughout the 52nd Pct. were reviewed
 - 2) Impact zone is in place with the addition of new officers
 - 3) Deputy Inspector Alles responded to questions from the audience.
 - C) Sirio Guerino:
 - Thanked the Board for the approval of a plaque at the Reservoir Oval honoring Frances Lewis.
 - Cited graffiti problems throughout the CB area and expressed concerned regarding the need for a clean-up
