VIII) 52nd Precinct:

- A) No one was present from the Police Department. No reports were provided at this time
- B) Most police officers were assigned to attend the tragedy of the crane collapse in Manhattan
- C) Board members are disturbed by the lack of communication by the 52nd pct. explaining their absence

IX) Committee Reports:

- A) Education / Libraries Committee
 - 1) The Committee is set to meet on Monday, March 24th, 2008
 - 2) Future problems about schools in the northern part of the district need to be discussed. There will be planned meetings with CB8 and CB12 for greater support in dealing with the DOE and the School Construction Authority around these issues

B) Parks Committee:

- 1) There was a report from the Task Force regarding the following issues:
 - a) Harlem Hudson Waterfront
 - b) Putnam Rail Lines
 - c) Aqueduct / University area
 - d) The Grand Concourse
 - e) The Bronx River
- 2) There was a motion to accept the draft of "The Bronx Greenway Report". Motion was approved
- 3) There was a discussion about the possibility of a farmer's market at Jerome and Mosholu on Park Land

C) Senior Services Committee:

- 1) Reported on the meeting held on March 3rd with the Senior Centers Directors of CB7
- 2) Resolution: "Community Board #7 urges the Borough Presidents of Queens, Brooklyn, Manhattan, as well all local Community Boards to be very careful before accepting the changeover of Meals on Wheels from a localized service of daily cooked meals by local agencies with direct contact to clients. What you hear from DFTA is not true. There was no waiting list before the program was started.

More than half of our Seniors have dropped out of the program after receiving either frozen meals or reheated frozen (these are their only choices). Most workers were not hired or offered any jobs by the two agencies that took over the contracts and there was actually no cost savings at all. Telephone reassurance has not worked and a separate study funded by a foundation was done by one our agencies which documents the dissatisfaction (DFTA has tried to suppress this). We are inclosing copies of this study for the three Borough President's to use and share at your own
