GENERAL COMMUNITY BOARD MEETING MINUTES Tuesday, September 20, 2011 @ 6:30 PM

Meeting held at: Bedford Park Senior Center ♦ 243 East 204th Street ♦ Bronx, 10458

- I) Public Session opened at 6:35 PM
- II) Paul Foster spoke before the public session to talk about Ozzie Brown and his contributions to the Board and the community. A minute of silence was held
- III) Public Session began with the following speakers:
 - A) Jose Quintana, Department of Health:
 - 1) Spoke about Health Bucks, a program dealing with obesity and obesity related illnesses. They provide free coupons to buy farm-fresh fruits and vegetables. They have been holding meetings throughout the Bronx
 - B) Aurelia Greene, Deputy Borough President:
 - 1) Talked about the Borough President's Education Summit to be held at the Borough President's Office to discuss issues around education and health of Bronx school children
 - 2) The Summit is to be held on Saturday, October 15, 2011 at Lehman College between the hours of 8:30am and 4:00pm
 - C) Joseph Dowling, 52nd Pct. Deputy Inspector:
 - 1) Discussed the Stats and recent arrests
 - 2) He advised that apartments be secured to avoid burglaries. A police officer is available to advise people without charge. He is asking people to take advantage of this benefit
 - 3) Quality of Life issues were discussed
 - 4) Auto theft and recovery of stolen cars were discussed
 - 5) The Inspector took questions from the audience and promised to look into the issues presented
 - D) Jeffrey Dinowitz, Assemblyman:
 - 1) Mentioned the Town Hall Meeting to be held at Mosholu Montefiore Community Center On Wednesday at 7:30pm
 - 2) The Town Hall Meeting is to discuss issues that affect the Quality of Life of community residents
 - 3) Spoke about the Oval, trees, Jerome Avenue BID Festival on Saturday, September 24, between the hours of 10:00am and 6:00pm
 - 4) He discussed protection of the rent laws to keep apartments reasonably priced. He will address those not needed apartment repairs that cause rent increases
 - 5) Car thefts could be prevented if VIN numbers were placed on the vehicle's rims/wheels. Legislation is pending
 - 6) Filtration Plant costs have risen to \$3Billion as of now, causing increases in water rates
 - E) Louis Burns, Jericho Project:
 - 1) Talked about housing for the homeless and especially veteran housing on East 194th Street; A 56-unit costing \$53 Million. He is requesting recommendations from the community for placement in the housing
 - F) Sharon Jarvis, Bronx Library Center:
 - 1) Spoke about "Financial Management workshop and information center"
 - 2) "Connect now" is for youth at risk who are preparing for their GED
 - 3) Civic workshops to be presented
 - G) Guillermo Flores, American Cancer Society:

Any issues that you would like to submit to be included in the statement are due by Oct 3rd. Samples from previous years are available on our website under the Budget Committee
- 5) Website revamp as per recommendations from committee. Need volunteers to submit content. Submitting a complaint and major complaint issues (parking, dog waste, etc.)
- 6) Economic Development GIS project. In partnership with Lehman College, created maps based on the district economic census conducted in May 2010.
- 7) Economic development interns for September 2011. Two interns from Lehman College, Flor Cabrera and Albert Abreu, who will conduct a reassessment of the areas surveyed and update our master list of businesses in the district and surrounding areas. Will also evaluate business and consumer needs.
- 8) Yankee Youth Award nominations being accepted for 2011. Need to be submitted to the Yankees Community Council no later than November 14th (submit nominees to the office).
- 9) Letter from Montefiore to be part of the hospital's new Asthma Initiative. Was due in August, but would like to know if the Board is still interested in participating.
- 10) CB8 will have a Public Hearing regarding the Van Cortlandt Park Ice Skating Rink Proposal to be held on Tuesday, October 4th at 7:30 PM at 5676 Riverdale Avenue, Suite 100.
