# **GENERAL COMMUNITY BOARD MEETING MINUTES**Tuesday, November 20<sup>th</sup>, 2012 @ 6:30 PM Held at: Scott Towers ♦ 3400 Paul Avenue ♦ Bronx, NY 10467

- I) Meeting opened at 6:40 PM. Ms. Adaline Walker presided over the meeting in place of Mr. Paul Foster
- II) Public Session began with the following speakers:
  - A) Christina Pena, Friends of Woodlawn Cemetery:
    - 1) Introduced the program offered by Woodlawn Cemetery. Pamphlets distributed
    - 2) Volunteers needed to help at the 150<sup>th</sup> Anniversary
  - B) Mohammed Ali, CB7 Member:
    - 1) Reported on problems at PS 340 Kindergarten; The move of children to another school outside their area. Wants DOE to reconsider these actions. There are large class sizes and overcrowding that need to be addressed
    - 2) Asking for support from the community to oppose DOE's actions. Problem will be referred to the Education Committee
  - C) Inspector Joseph Dowling, 52<sup>nd</sup> Precinct:
    - 1) Talked about the effects of the hurricane on the community-at-large. The question of the Apex Center at Lehman for affected victims was discussed
    - 2) The stats were reported on. Crime is down except for burglaries
    - 3) Arrests were made on the recent shootings in the precinct
    - 4) Homicides are down for the year
    - 5) Inspector Dowling reported on various crimes throughout the community, which have been solved
    - 6) Warnings were made about leaving valuable things visible in cars to avoid break-ins
    - 7) Inspector Dowling answered questions, and then introduced Eamon Deary, the new Captain at the 52<sup>nd</sup> Pct.
  - D) Councilman Oliver Koppell:
    - 1) Spoke about the Council and their involvement in the recent hurricane
    - 2) He complained about the lack of response by ConEdison throughout the community
    - 3) He also spoke about preparedness and the effects of climate control
    - 4) The NYC budget was discussed. He spoke of the 5-year school construction budget. P.S.177 will be funded soon and P.S.56 will have a new addition
    - 5) Disaster relief needed to be funded with hopeful reimbursement from the Federal Government

- 6) The construction of the Filtration Plant is approaching the end
- 7) Oliver introduced his Aide, George Diaz, who attends CB Meetings faithfully
- 8) Questions were responded to by the Councilman. Schools were of great concern to the audience
- E) Assemblyman Jeff Dinowitz:
  - 1) Discussed the MTA meeting that he attended and presented testimony
  - 2) Fare increases were opposed, and he feels that NY State needs to financially support the MTA
  - 3) Concern for the minimum wage and needs reform
  - 4) Coop Tax abatement was a concern and needs reform
  - 5) The Title 20 funds were of great concern and is safe for the time being
  - 6) The Assemblyman introduced Andy Cohen who will be working on Senior issues
- F) Assemblyman Elect Mark Gjonaj:
  - 1) Greeted the audience and spoke of the damages from the recent hurricane
  - 2) He invited all to visit his office, which is opened to address issues even before he is officially sworn in
  - 3) Mark Gjonaj promised a consistent presence in the community
- G) Sonia Lappin, Scott Towers Resident:
  - 1) Sonia welcomed all to Scott Towers and expressed her concern about the need to know the procedures in the event of a catastrophe
  - 2) Expressed her objections to the proposed housing at Villa Avenue. Ms. Lappin distributed a statement that described the inability of the organization to conduct a housing development of the nature described. The audience voiced their concerns about this project
    - a) Oliver Koppell spoke up about the housing and will be in touch with community residents to review the projects. He stated that the group may build the housing "as of right"
    - b) Oliver will arrange for Seniors and interested parties to visit other facilities run by this organization
  - 3) The question of funding was raised and will be pursued
- H) Phillipe Della Santo, Team 16:
  - 1) Economic Issues and the Ice Skating rink proposed for the Armory was discussed
  - 2) Wants to raise awareness about issues and solutions to address them
