GENERAL COMMUNITY BOARD MEETING MINUTES Tuesday, January 15, 2013 @ 6:30 PM

Held at: Bronx Library Center ♦ 310 East Kingsbridge Road ♦ Bronx, NY 10458

- I) Paul welcomed all in attendance, informed all about the applications for Board Membership and Public session opened at 6:35pm with the following speakers:
 - A) Kawsar Ahmed, Community resident:
 - 1) Representing the Bangladeshi American Association has concerns about safety in the community around Perry, Hull and Webster Avenue at East 203rd, 204th, 205th, 206th and 207th Street
 - B) Joseph Dowling, 52nd Pct Inspector:
 - 1) Addressed the community and introduced John Wilson who will be promoted to Captain in 2 weeks and will be assigned to the 52nd Pct.
 - 2) Inspector Dowling reviewed the stats. Robberies are up, assaults and burglaries are down. Gold Chains and cell phone robberies still a problem. Also, Grand Larceny Auto is down
 - 3) This year we are up 8 crimes in the last 28 days
 - 4) There were some shootings which seem to be gang related. The PD is on top of these crimes and expect resolution shortly
 - 5) Inspector Dowling then fielded questions from the audience
 - 6) Inspector Dowling will also speak to the representatives from the Bangladeshi community to address the problems that were stated here
 - 7) The Clean Halls project situation was raised. Although changes may be coming, but presently the Inspector will assist any tenants who have concerns
 - 8) The impending bus strike and procedures for parents was discussed
 - C) Jeffrey Dinowitz, Assemblyman:
 - 1) Jeff reported on the new gun laws that were just approved which includes a Mental health component a professional will refer patients who appear to be of danger to others
 - 2) Spoke about the new gun laws that were passed today in Albany. It is the toughest in the nation
 - a) Assault weapons banned or registered through proper channels
 - b) Stronger regulations on ammunition. There will be a limit of 7 rounds in a weapon rather than a capacity of 10 rounds
 - c) Purchase of guns and ammunition will be housed in computers for all time
 - d) Universal background check will be required
 - e) When First responders are shot there will be a felony conviction for the shooter
 - f) Safety storage of guns and ammunition will be enforced
 - g) The Assemblyman then fielded questions from the audience
 - D) Sharon Jarvis, Bronx Library Center Director:
 - 1) Welcomed all to the Library
 - 2) Has \$200,000 grant for new computers for public use
