GENERAL COMMUNITY BOARD MEETING MINUTES Tuesday, March 18, 2014 @ 6:30 PM

Held at: Mosholu Montefiore Community Center ♦ 3450 Dekalb Avenue ♦ Bronx, New York 10467

- I) Public Session started at 6:40 pm. with the following speakers:
 - A) Captain Rock-Wright, 52nd Precinct:
 - 1) Spoke about protecting your cell phone when using it
 - 2) Protecting your identity from being stolen. One should destroy anything with your name on it
 - 3) One should be careful at ATM Machines
 - 4) The Precinct has been talking with bike delivery individuals about safe use of their bikes and having proper identification on the bike as well as themselves
 - 5) At the March 27, 2014 Precinct Council Meeting (being held at St. Ann's Church), there will be a presentation on Gangs. Police Officer Cortez from the Community Affairs Unit was also present.
 - B) Ronn Jordan, Councilman Ritchie Torres' Office:
 - 1) The office is now located at 573 East Fordham Road (Hoffman Street). Office phone is 718-842-8100.
 - C) Timothy Tapia, Public Advocate's Office:
 - 1) Reported that their office was working on making lunch free for all New York City public school students
 - D) Joshua Cortes, Councilman Fernando Cabrera's Office:
 - 1) Reported that the office now has a family justice lawyer who is available by appointment.
 - 2) The Councilman is working on a law that would require the fixing and/or replacement of a broken traffic signal within 24 hours
 - 3) March 21, 2014 is the final date to apply for discretionary funds and April 9, 2014 is the final date to apply for capital funds
 - E) Bryant Daniels, Assemblyman Jeffrey Dinowitz' Office:
 - 1) Talked about the Norwood Slow Zone. The work on the slow zone will start in May 2014. Lowell Green, Chair of Traffic and Transportation Committee, said that the gateway signs for the slow zone are now placed on the sidewalk rather than in the street. As a result, there should be no lost of parking spaces
 - F) Tom Lucania, Borough President's Office:
 - 1) Reported that there was a fire at 2580 Briggs Avenue that affected 22 apartments. Red Cross was on site to help people
 - The Borough President is having a Poster Contest on the subject of "Respect Our Block"

 - 1) Introduced Mr. David Rose who is the President of the Fordham BID to the body
- D) Education/Libraries/Cultural Affairs & Youth Services by Bruce Kaufman:
 - 1) Announced that the Neighborhood Advisory Board had openings for new members
- E) Environment & Sanitation by Helene Hartman –Kutnowsky:
