# A. Metro-North Penn Station Access Update

**Project Overview** 

- New Metro-North rail service to and from Penn Station
- 4 new ADA stations in the Bronx; reduce commutes to Midtown up to 50 minutes each way
- Regional transportation connectivity
- Upgrade Amtrak's Hell Gate Line to a state of good repair
- New Rochelle Yard Expansion

Overall Project Benefits: Decreased Travel Times, Optimizing Existing Infrastructure Enhanced Network Reliability, Economic Vitality, Sustainability, Reverse Commuting Opportunities, Bridging Communities, Regional Transportation Connectivity Amtrak and Freight Railroad Benefits:

- Improves on-time performance and reliability for intercity passengers
- Brings Amtrak's Hell Gate Line to a state of good repair, including: Hell Gate Line catenary system 100+ year old bridge structures
- Electrical upgrades, improved signal system, and state-of-the-art communication system
- Significant enhancements to stormwater management including new drainage Upcoming Work 2023-2024 include commission Leggit crossover, special track work component

Street Level Impacts: East Tremont Road:

- Temporary parking restriction and sidewalk closure on northbound East Tremont Road between Bronxdale Avenue and Unionport Road.
- A 5-foot protected pedestrian pathway will be maintained at this location.
- Beginning on or about November 1st, 2023, lasting until January 2024.

The board previously approved this BSA in 2014, the request is for another 10 year extension. This location has no issues with neighbors and has been good to the community. The request is really for the back end of the property as it falls in residential zoning, half C8 and the other half R6.
