## A. Council Member Farias, Industrial Development and Manufacturing Zones

As per CM Farias, her legislation, Introduction 1012-A, will require city agencies to develop a comprehensive, citywide industrial development strategic plan for manufacturing and industrial business zones – something that has not been done since 1993 nor have zoning changes been made for industrial zones since 1961. This bill is finally filling a decades-long gap and offering overdue support to a vital sector of our economy. "When we protect industrial business zones and industrial jobs, we are also protecting our working-class families, unionized workforce, and businesses that boost our communities. These strategic plans will ensure that we are both growing our city's workforce and that industrial zones have comprehensive planning that are protective of our existing infrastructure."

CM Farias is proud to support the future of NYCs's industrial workforce for generations, grow the local economies, and support the emerging green economy with this critical legislation.
