### COMMUNITY BOARD TEN BOARD MEETING SEPTEMBER 18, 2017 – SHORE HILL COMMUNITY ROOM MINUTES

Chair Cruz called the meeting to order at 7:20 PM and invited Mary Ann Walsh, former longtime Community Board Ten Member, to lead the Honor of the Pledge.

Chair Cruz asked for a motion to adopt tonight's agenda. Motion by BM Sokoloski, seconded by BM D'Amelio.

Chair Cruz asked for a motion to adopt the Minutes from the June 19, 2017 Board Meeting. Motion by BM Rasinya, seconded by BM Sokoloski.

Council Member Vincent Gentile thanked all for their support and announced that he will be around until December 31<sup>st</sup>. The Councilman stated that indoor hookah smoking was never part of the Smoke Free Air Act. His bill, which has been in the works for the past seven years, will pass on September 27<sup>th</sup> and will now include hookah smoke. Those with 50% or more of their revenue currently coming from hookah will be permitted to remain open if they adhere to new regulations. They must file a permit, raise the age to smoke hookah to 21, impose new ventilation requests, will not be permitted to relocate or expand their establishments, and there will be new FDNY requirements.

On 9/30/17 the Illegal Conversions Bill goes into effect. It is the strongest bill to go into effect to date regarding illegal conversions.

There was a City Council Transportation Committee hearing on 9/18/17, new bill will require DOT to paint curbs near hydrants and bus stops. DOT is opposed to this.

Introducing a new bill called the Shorefront Notification Package where elected officials and Community Boards are notified when dangerous chemicals spill along shoreline.

DSNY announced new bulk trash regulations involving calling 311 for a pickup appointment.

Parks Department 97<sup>th</sup> Street ramp construction has begun. They have cleared trees and pathways.

Our Lady of Angels is celebrating their 125<sup>th</sup> anniversary. A street naming will be held Saturday, Sept. 23, 2017 at 6PM on the block of 73<sup>rd</sup> Street and 4<sup>th</sup> Avenue.

Assemblyman Peter Abbate announced that a special session on mass transit has been called for October 17, 2017. Assemblyman Abbate spoke about the primary election. There were nine candidates for City Council in this 43<sup>rd</sup> Council District and we had the lowest turnout in the city. He stressed that the community must come out to vote.

Fran Vella-Marrone, Dyker Heights Civic Association and member of Guardians of the Guardian (organization to advocate for senior housing) spoke about putting senior housing at the former Angel Guardian Home on 64<sup>th</sup> Street between 12<sup>th</sup> & 13<sup>th</sup> Avenue. Chair Cruz said CB10 supports senior housing but funding is needed for it and that they should seek out elected officials to help provide funding. BM Johnson commented that very frequently lifelong local residents in need of senior housing are not able to get into Shore Hill, while recent immigrants who are not citizens are accepted.

Yveline Dalmacy, representing Assembly Member Pamela Harris introduced Stephanie Gales a new staff member who will be regularly attending CB 10 meetings. Will introduce new legislation to fund MTA

Tom Greene invited all to come to Denyse Wharf on Oct. 22, 2017 to look at the site. They want to put a steel chamber for storing equipment that they use to clean the wharf. He reminded all of the Eco Dock failure at the 69<sup>th</sup> Street Pier.

Jessica Kallo, Borough President's Office, Community Board Liaison welcomed board members and new board members and gave her telephone number 718-802-3813 if anyone has any questions about the community.

Romeo Petric inquired about the 97<sup>th</sup> Street ramp. He said the fence was up but nothing else has been done. CM Gentile clarified that he had already spoken earlier that trees and pathways have been cleared in preparation for construction.

Patrick Lewis, Public Advocate's Office. He announced that all NYC students would now be entitled to free breakfast and lunch.

Daniel Costantino DSNY employee and Board of DSNY Columbia Organization. He and his son, Daniel announced various fundraisers. The month of September they are having a coat drive and are working with Investor's Bank, Toys R Us, and Chipotle. Drop off new or gently used coats at any of their locations but the main event is on Sept. 30 at Investor's Bank, 7414 13<sup>th</sup> Avenue from 9am – 2pm. The coats will be donated to The Salvation Army on 86<sup>th</sup> Street.

### POLICE AND PUBLIC SAFETY COMMITTEE

Police and Public Safety Committee Chair Willis rendered the Committee report. See Attached.

Motion: CB 10 to approve the new SLA Wine/Beer/Cider application for Toscana Al TerzoLLC., d/b/a Tuscany Grill, 8620 3<sup>rd</sup> Avenue. All in favor. Motion carried.

Motion: CB10 to approve the new SLA Wine/Beer/Cider application for Shahajalal Foods, d/b/a Taj Mahal Indian Restaurant, 7315 3<sup>rd</sup> Avenue. All in favor. Motion carried.

Motion: CB10 to approve the new SLA Wine/Beer/Cider application for Tacos El Nopal, 8321 5<sup>th</sup> Avenue. All in favor. Motion carried.

Motion: CB10 to disapprove the new SLA Wine, Beer, Cider Application for Patsy's Bay Ridge LLC. d/b/a Patsy's Pizzeria, 8814 3<sup>rd</sup> Avenue, Brooklyn, NY 11201, unless the following stipulations are agreed to and met:

- 1. Dancing, live music, and d.j. are permitted only during private parties.
- 2. Music is permitted only until 2:00 a.m.
- 3. The doors of the premises must remain shut during the playing of live music, amplified music, d.j., and during parties.
- 4. There will be no use of promoters or promoted events.
- 5. The premises will operate as a restaurant and the licensee will notify Community Board 10, consult with, and appear before Community Board 10, at least three (3) months in advance of any change in the method of operation or alteration to the licensed premises.

### All in favor. Motion carried

Motion: CB10 to approve the recommendation of the Police and Public Safety Committee for an SLA Alteration Application at Osteria Positano, LLC d/b/a Positano, 10018 4<sup>th</sup> Avenue. Discussion followed. Several Board Members confirmed that the unlicensed sidewalk café was in use through the weekend up until this evening. BM Harrison added that at the committee meeting they said they would cease use immediately until the paperwork for the outdoor café was corrected but they did not cease use of the café. This is problematic. BM Rasinya added that they have a two year history of non-compliance where the outdoor café is concerned. BM Kieran added that it would be difficult to trust them at this point.

Motion: CB10 to approve the recommendation of the Police and Public Safety Committee for an SLA Alteration Application at Osteria Positano, LLC d/b/a Positano, 10018 4<sup>th</sup> Avenue. All opposed. Motion failed.

Motion from the floor by BM Rasinya, seconded by BM Kieran: To deny the SLA alteration application for Osteria Positano, LLC d/b/a Positano, 10018 4<sup>th</sup> Avenue and notify SLA of the alleged violation of the current liquor license by serving liquor in the unlicensed sidewalk café and to notify DCA of the unlicensed sidewalk café use.

29 in favor; 1 opposed - BM Masyr. Motion carried.

### **ZONING AND LAND USE COMMITTEE**

Zoning and Land Use Committee Chair Kaszuba rendered the Committee report. See attached.

ZALUC Chair Kaszuba spoke about the Northern Dyker Heights Development Study. The study was completed by Michael Devigne, a Community Board Ten fellow in preparation of our review of a large scale project at 6200 8<sup>th</sup> Avenue which includes housing, hotel, retail space, school and underground parking. There is currently an environmental impact study being performed for this project. The Northern Dyker Heights study examined the surrounding area from 48<sup>th</sup> street to 79<sup>th</sup> Street and 7<sup>th</sup> Avenue to 14<sup>th</sup> Avenue. ZALUC will be looking for a new Urban Fellow who will produce a traffic report of the subject location to see how this development will affect traffic, go in depth regarding illegal conversions and what can be done, and conduct a mapping project of CB10's needs based upon 311 open data.

Comments were made about how this development would affect our already overcrowded school district, the extreme vehicular congestion in the area already and how the additional traffic does not fit. BM Willis asked if this is an as of right project and Chair Kaszuba said that unfortunately all of this would be an as of right project due to the approval that they received in 2007 and the only say the Community Board would have is regarding the location over the railroad tracks. BM Harrison called this a bait and switch, since we had voted to support a much lower scale project that included a Home Depot back in 2007. BM Capetanakis added that since the

Home Depot project approval, we as a Board have talked about general concerns. The study will provide information and we will continue to discuss the issue and be well prepared when the proposal comes back to the Board. This is a densely populated area and we need to discuss how our schools would handle the large number of families and children. Chair Cruz announced that joint ZALUC/Youth Services, Education, Libraries, Committee meeting will be scheduled to discuss this development.

### TRAFFIC AND TRANSPORTATION COMMITTEE

Traffic and Transportation Committee Acting Chair Rasinya rendered the Committee report. See Attached. Discussion followed.

Acting Chair Rasinya spoke about five proposed City Bench locations. He stated that at 1298 Bay Ridge Ave., the delicatessen owner objected to the proposed bench. At all other locations the building owners/managers supported or had no objection to placement of the benches.

Motion: To disapprove the request for a City Bench at 1298 Bay Ridge Avenue, and to support proposed City Bench locations at 9920 4<sup>th</sup> Ave., 7821 3<sup>rd</sup> Ave., 8201 3<sup>rd</sup> Ave., and 745 64<sup>th</sup> with the provision that benches placed are backless with partitioned seat dividers. All in favor. Motion carried.

BM Mulé mentioned a bench on 5<sup>th</sup> Avenue between 92<sup>nd</sup> and 93<sup>rd</sup> Street near Staples parking lot that is a dumping ground and an attraction for homeless individuals.

### **Old Business**

BM Harrison mentioned that the 53<sup>rd</sup> Street R station has reopened and asked when the Bay Ridge Ave. R station will open. Chair Cruz responded that is should be soon, possibly Oct 2017.

BM Stelter noted that drag racing continues on Bay Ridge Parkway. Chair Cruz said a T&T meeting is scheduled to address 86<sup>th</sup> Street drag racing.

BM Gounardes brought up National Grid street work and issues with DOT street resurfacing, stating that cars were being towed today on 70<sup>th</sup> Street with no notification, and no signage posted. Chair Cruz said the National Grid work has been a very difficult project.

The District Office received a response from the DOT about our concerns about the placement of an elevator at 86<sup>th</sup> Street and 4<sup>th</sup> Avenue. We feel the design will create a dangerous situation at an already dangerous intersection. The DOT stated that they do not see any problems with the design and if there are problems, they will address them later. This issue will be discussed by the Traffic and Transportation committee and a response will be formulated. Stay tuned –

We have a new chair of Senior Issues, Health and Welfare committee, Iris Mule. We welcome her and know that she will have a busy year.

We have new members on the Parks committee and will be reviewing and monitoring currently funded projects and looking at all parks issues.

The Education, Libraries and Youth Services committee has new members and we will be looking at effort to support our 4 local libraries and to try to get new schools built in our overcrowded district.

Zoning and Land Use will be further reviewing the Northern Dyker Heights study.

And the Environmental Committee will be addressing the issues resulting from pickup changes with the advent of board wide organic recycling.

At the Boro Hall orientation, there were four areas of discussion, budget, zoning and land use, conflicts of interest and members roles and responsibility. As part of the members roles and responsibility portion attendance and participation was stressed. Let us all commit to good attendance and participation this year.

### District Manager Report September 18, 2017

### Good Evening Board Members:

I hope you all enjoyed the summer hiatus.. welcome back! I would first like to welcome our newest staff member Joan DiBello-Karim. I am happy to share the following updates with you regarding issues we worked on this summer.

### **SCA PROJECTS**

Construction has begun on PS 102's masonry exterior and will last until February of 2019. Work is taking place after school hours with the permit granted until midnight, although loud work must end by 10:30 pm. We will be monitoring this job as it relates to quality of life issues for surrounding residents as we have received several noise related complaints. If loud work does not end by 10:30 pm, I would advise that residents log a complaint with 311 and advise the district office.

Also, McKinley Junior High School – ongoing roofing work at night. We have received several complaints of tar like odors and I have talked to the SCA and we will be monitoring complaints.

Dyker Junior High School – at long last construction work is near completion. As you know, our Parks Committee has been working with a group of interested residents seeking to lock Patrick O'Rourke Playground - as the group of residents who formerly volunteered to do this have retired. In addition fencing was added to 80<sup>th</sup> Street and we are awaiting a panel to be replaced on the fencing at 81<sup>st</sup> Street. Once this is complete.. and we hope by next week – CB10 will assist neighbors and Partnership for Parks with a new group of community volunteers to lock the park.

### **NYC Parks Updates**

**Tree pruning** is taking place in Community Board Ten. In addition the NYC Tree and Sidewalks program is in our Community Board repairing sidewalks and expanding tree pits where tree roots have significantly raised the sidewalk. This has also brought us several complaints about sidewalk access and the duration of the work.

97<sup>th</sup> Street Ramp Construction – NYC Parks Commissioner Martin Maher called to say that the contractor has fenced off a larger footprint to begin work on the restoration of the ramp. It is not a simple job. NYC Parks is trying to explore a bypass option as the fenced off area has generated several community complaints. The bottom line is that there will be an accessible completed ramp within the year.

**Dyker Beach Park Soccer Field** – 14<sup>th</sup> Avenue between Bath and Benson Avenues has started construction. This is a \$2.5 Million Dollar project funds secured by CM Gentile. It will have new synthetic turf and the entrance will be repayed. It is expected to be completed within the year.

MILLING AND RESURFACING – Milling and Resurfacing has begun in Community District 10. As many of you know the full list of streets that will be done were emailed out to you and posted on our website. The first few days of milling began on Bay Ridge Avenue from Shore Road proceeding east toward 7<sup>th</sup> Avenue. The District Office received several calls from very frustrated residents and commuters because of confusion relating to bus operators who were diverted and miscommunication about temporary diversions. I reached out to Melissa Farley asking for improved efforts to communicate to commuters regarding disruptions caused by milling and paving along -- Bay Ridge Avenue - Shore Road to 7 Avenue -- B9, B64, X27, X37; 13th Avenue - 65th Street to Bay Ridge Parkway -- B64; 7th Avenue - Bay Ridge Avenue to 79 Street -- B 70

**Block Party** – Street Activity Permits Summer of 2017 included 64 applications to Community Board Ten.

**Dyker Lights Update** – I will be meeting with the Street Activity Permit Office to discuss the dyker lights permit in early October. CB10 will then host a community meeting with Dyker Heights residents in the viewing area by the first week of November. I will keep you updated as the permit is expected to assist by providing additional city resources including police, traffic control and sanitation services.

**Angel Guardian Home** – The District Office has received over 500 letters from mostly Brooklyn residents addressed to the Sisters of Mercy supporting senior housing at the site. We have also received several phone calls to the District Office registering support for senior housing. CB10 voted in May to ask the SCA to explore this site as a possible school location and we have not yet heard back from them. Senior housing is a great need is CB10 yet funding unfortunately is lacking.

**Budget Consultations** – Each year Community Boards meet as a Borough with several agencies of the City of New York to discuss budgetary needs. Individual Community Boards hold district budget consultations at the District Cabinet Meeting during the month of June to begin to prepare our list of Expense and Capital Priorities for the upcoming fiscal year. During the month of October, Community Boards then hold a public hearing and prioritize those needs which you will vote upon next month.

I wanted to advise you that this year we will conduct our Public Hearing on the Capital and Expense Budget Priorities at a separate meeting, to be held **on Monday October 2nd at 7:00 pm** at the District Office, rather than at the October Board Meeting as has been past practice. This will allow more time dedicated solely to the presentation and review of potential budget items. I encourage all new Board Members to attend on October 2<sup>nd</sup> as well as Executive Board Members.

**Con Edison Meters** – Smart meters are coming to our Borough. Con Edison will be installing smat meters to help achieve our energy goals. Our Environmental Committee will be hosting a presentation on this exciting news in the next few weeks.

National Grid New Trench Requirements – As you know there has been a great deal of National Grid upgrade work in Community District 10. In addition to Local Law 30 work - there are several blocks that are undergoing new pipe installation. National Grid has informed us that they have hired an additional four contractors to help with Local Law 30 work. There has been an increase in complaints relating to final restoration work at many National Grid sites. I want to explain that this is because DOT requirements were recently changed relating to the restoration of the trench. It is now a multi-step process. The changes require that cements be poured before final asphalt is made to the trench. This will require more time from excavation to final restoration of open trenches.

**BED001A** = This is the watermain replacement project currently taking place in Dyker Heights along 12<sup>th</sup> and 13<sup>th</sup> Avenues – now working on 77<sup>th</sup> Street toward Bay Ridge Parkway. The District Office has yielding several complaints and continues to work with our DDC liaison and hopefully all work will be completed here by next week.

### **ANNOUNCEMENTS**

Ragamuffin Parade will take place on Saturday, October 14<sup>th</sup> and the 3<sup>rd</sup> Avenue Festival will take place Sunday, October 15, 2016 – 3<sup>rd</sup> Avenue from Bay Ridge Avenue to 94<sup>th</sup> Street

The Columbia Association of THE DSNY has asked us to spread the word about their Coat Drive which will take place on Saturday, September 30<sup>th</sup> from 9am to 2pm they are partnering with Investors Bank to collect new or gently used coats to distribute throughout the area. On September 30<sup>th</sup> they will be collecting coats at 7414 13<sup>th</sup> Avenue.

The City of NY Law Department has sent a letter to CB10 inviting youth to apply to become a part of the Family Court Division Youth Leadership Council of the NYC Law Department. They are seeking high school students between the ages of 14 to 21 to be the youth voices we need to improve policies in the City of NY. The application submission deadline is Monday, October 9<sup>th</sup>.. information will be posted on our website.

I would like to take a moment to congratulate CB10 Board Members Judith Grimaldi and Joanne Seminara who will be honored by the Neighborhood Improvement Association at their annual dinner on September 28<sup>th</sup>.

Bay Ridge Cares will be refurbishing the kitchen at the Fort Hamilton Senior Center and still needs some volunteers if you have time on October  $7^{th}$  and  $8^{th}$ .

### **DSNY BULK ITEMES**

### Introduction

The ZALUC Committee Meeting met at 7:00 on June 27, 2017 at the CB 10 District Office. The Committee did meet in quorum.

### Topic #1: Informational on Northern Dyker Height Development Study

Michael Devigne, who completed his time as our Urban Fellow in June, gave his final presentation on the Northern Dyker Heights Development Study. As we discussed last year, the Board is expected either later this fall, or early spring, to have to vote on a development project located at 6200 8<sup>th</sup> Avenue. The project which is presently undergoing an environmental impact study, is expect to be a large-scale project which includes housing, retail, commercial space, and a hotel. By studying the surrounding area, the Board wants to be proactive and ready to make a fully informed decision based upon the needs, and trends of our community.

The goals of the study were to look at changes in the neighborhood such as demographic changes, changes in housing and how the developments have been occurring, look for soft sites where other new developments could happen, look at how the new project could affect businesses in the area, and look at how this area compares to Flushing Queens, where Raymond Chan, the developer of the project has done previous work.

The study area goes from about 79<sup>th</sup> Street to 48<sup>th</sup> Street and from 7<sup>th</sup> Avenue to 14<sup>th</sup> Avenue. The area overlaps with parts of CB 7 and CB 12.

- The report notes that there have been large population growths in the study area with an average of 15% growth, however some locations in near 65<sup>th</sup> Street in Dyker Heights have seen growth over 30% since 2000.
- The report notes that 56% of the building stock in the area are 1-2 family homes, and 25% are multi-family walk-up buildings.
- Each residential unit averages 3.4 people, but several areas reach as high as 4 people per unit.
- The report also reviewed where there are soft sites in the area, which includes locations with underbuilt FAR, but also industrial areas that may not be zoned for large development now, but where that could change. There is also a new program, where the City is looking to build on unused religious institution sites such as parking lots, to build new housing.

- In the appendix of Michael's report, he looked at each census tract in the target area and was able to identify vacant land, where soft sites lay, locations of building alterations, and where there have been illegal conversion complaints.
- The report notes year by year illegal conversation complaints. Prior to 2014, CB 10 was behind CB 7 & 12. Since then CB 10 has spiked and is now higher than the neighboring boards.
- The report also noted that there has been a huge increase of alteration #2 permits that are self-certified since 2000 in the study area and 63% of permits issues in CB 10 are Alt #2. There does seem to be a correlation between self-certified permits and illegal conversation complaints.

Next steps for a new fellow would be:

- Prepare a traffic study of the subject area.
- · Go more in depth into the illegal conversation raw data.
- Conduct a mapping project of CB 10 needs based upon 311 open data.
