## **CCRB Welcomes Frederick Davie as Acting Chair**

*Outgoing Acting Chair Archer to Continue as Visiting Professor of Clinical Law at NYU School of Law, Professor of Law and Director of Racial Justice Project at New York Law School*

**New York, NY** – The Civilian Complaint Review Board, the nation’s largest independent police oversight entity, announced today the departure of Deborah Archer from the Board. Frederick Davie assumes the role of Acting Board Chair as Ms. Archer continues to serve as a visiting professor of clinical law at the New York University School of Law and director of the Racial Justice Project at New York Law School, where she also is a law professor.

**Statement from CCRB Executive Director Jonathan Darche:**

“Deborah Archer’s character and thoughtful leadership have been front and center throughout her tenure at the CCRB. Twice the City called on her to serve as Acting Chair, and twice she answered. No one is more committed to this Agency and to the people of this city. I learned a great deal from working for Ms. Archer and admire her dedication to scholarship and legal advocacy. It is these aspects of her expertise, along with her sense of humor and good nature, that the entire staff and Board will sorely miss.

“The CCRB is privileged to have Frederick Davie assume the role of Acting Chair. Fred has a clear passion for making New York City a place where everyone is treated with dignity and respect. He undoubtedly will bring that spirit to this new role.”
