The New York City Department of Environmental Protection (DEP) is in receipt of the New York State Department of Environmental Conservation's (DEC) January 14, 2015 letter containing your review comments on the Westchester Creek LTCP submitted to DEC on June 30, 2014, in accordance with the 2012 CSO Order on Consent. DEP requested a 45-days extension for the comments responses; DEC granted an extension to April 14, 2015.

DEP's responses to the DEC comments are contained in the attached document entitled: Combined Sewer Overflow Long Term Control Plan for Westchester Creek Appendix E: Supplemental Documentation. The Supplement shall be considered Appendix E to the June 2014 Combined Sewer Overflow Long Term Control Plan for Westchester Creek.

It should be noted that in addition to responding to specific comments in the above reference letter, the revised Section 6, revised Section 8, revised ES and revised UAA also reflect modifications that DEP and DEC agreed upon relative to the attainment of DO criteria and recommended primary contact enterococci RWQC of 30 cfu/100 mL and 110 cfu/100 mL for GM and STV, respectively.
