Job Description		
<p>The NYC Department of Homeless Services (DHS) seeks an Agency Attorney Intern at its Prevention and Temporary Housing Intake Center (PATH). Under the direction of the Assistant General Counsel, the selected candidate's primary responsibility will be conducting case reviews and facilitate legal conferences for applicant families who challenge shelter ineligibility determinations. During the legal conference, the selected candidate will take into consideration any new information provided by the applicant, consider its relevance, and determine whether the new information would alter the original determination. The selected candidate will direct any additional investigation when warranted based on new information, and will draft final eligibility determinations in complex cases. Additionally, the selected candidate will assist with quality assurance analyses and audits to ensure compliance with applicable policies, procedures and governing laws concerning the Agency's intake and eligibility process, as well as other PATH operations. S/he will act as liaison to non-legal PATH staff for guidance on eligibility determinations and the implementation of fair hearing decisions.</p> <p>The selected candidate will also handle other legal assignments from the General Counsel's office, which may include representing the Agency at State fair hearings, serving as a liaison to the NYC Law Department on external litigation, responding to subpoenas, FOIL and other information requests, and drafting position statements in response to complaints filed with the Equal Employment Opportunity Commission, the State Division of Human Rights and the NYC Commission on Human Rights.</p>
