Job Description

The NYC Department of Homeless Services (DHS) seeks an Associate Staff Analyst to serve as an Energy Analyst within the Division of Administration. The Maintenance and Repair Unit is responsible for the facility maintenance in all homeless shelters. As part of the Mayor's "One City" initiative, by expanding our in-house Preventive Maintenance program, DHS will help meet the Mayor's initiative by properly maintaining and replacing mechanical systems with new and improved technologies. The selected individual would be responsible for supporting a wide variety of areas including operational improvements, preventative maintenance procedures, improved billing and reporting and information management. The Energy Analyst would help research new technologies, products and equipment, initiate and evaluate the effectiveness and cost-efficiency of energy conservation equipment and will study the feasibility of installing/applying such devices and systems to all City owned facilities. S/he will work closely with the Contract Tracking Unit (CTU) to help formulate, revise and submit contracts as it relates to energy management. The analyst will also work closely with DCAS to review energy bills and investigate energy consumption.
