Job Description

REPOST

The NYC Department of Homeless Services seeks 2 Community Coordinators to serve as After Care Coordinators within the Adults Division Unit. The Aftercare Coordinators provide direct support to single adults and adult families who exit the shelter system through various rental subsidy programs including Living In Communities (LINC). This will include calling and visiting clients who have moved out of the shelter system and offering a variety of supports including: intervening with the landlord to help resolve issues as appropriate, working with the Human Resources Administration (HRA) and other City agencies to ensure a smooth transition to permanent housing, and helping to connect individuals and adult families to community based organizations, supportive networks and appropriate social services, including mental health and substance use services, as appropriate. The Aftercare Specialists may also be asked to help work with clients placed at commercial hotels towards the goal of attaining permanent housing and perform administrative duties related to rental subsidy programs -- including data entry; maintaining records of each participant's case; calling brokers/landlords in the community to identify available housing resources; and providing general administrative and clerical support. Qualification Requirements

1. A baccalaureate degree from an accredited college and two years of experience in community work or community centered activities in an area related to the duties described above; or
2. High school graduation or equivalent and six years of experience in community work or community centered activities in an area related to the duties as described above; or
3. Education and/or experience which is equivalent to "1" or "2" above. However, all candidates must have at least one year of experience as described in "1" above.
