

**SUMMARY OF DISCHARGES OF INMATES WITH
FEDERAL IMMIGRATION AND CUSTOMS ENFORCEMENT (ICE) DETAINERS**

For Discharges October 1, 2015 – September 30, 2016

This report provides information regarding federal Immigration and Customs Enforcement (ICE) detainees that is required to be reported pursuant to City Administrative Code §9-131(f). In November 2014, the U.S. Department of Homeland Security (DHS) announced changes to its immigration enforcement policies and practices. ICE now uses requests for voluntary notification of release, in addition to immigration detainee requests.

- 8. the number of persons held pursuant to civil immigration detainers beyond the time when such persons would otherwise have been released from the department's custody who were not transferred to the custody of federal immigration authorities either because of the expiration of the forty-eight-hour hold period provided in 8 C.F.R. § 287.7 or because federal immigration authorities disavowed an intention to assume custody.
