

What are Project-Based Vouchers?

Similar to the regular Section 8 Housing Choice Voucher (HCV) program, Project Based Vouchers (PBV) require tenants to pay 30% of their income towards rent. However, whereas the regular Section 8 subsidy is tied to a tenant, the Project-Based Voucher subsidy is attached to a designated unit. Prior to occupying a PBV unit, eligible households will be provided with detailed information that explains their rights and responsibilities under the program.

Below are developments with units receiving HPD Project-Based Voucher subsidy, developments under construction that have entered into an agreement for future units to receive HPD Project-Based Voucher subsidy, and projects that have been conditionally selected to receive Project-Based Voucher subsidy in the future. Also listed are the eligibility requirements for each building and the development's contact information. If you believe you meet the eligibility requirements for any of these buildings and would like to apply for Project-Based Voucher assistance, please contact the development directly.

Key Definitions:

- **Name:** name of the PBV development
- **Location:** borough where PBV development is located
- **Unit Size:** bedroom size of units available at PBV development
- **Criteria for Residency:** specific requirements to be eligible to apply for units at the PBV development
- **Contact Information:** information to contact the PBV development with questions about application requirements
